





#### OI & Volume Chart



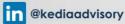

In Unjha, a major spot market, the price ended at 21331.5 Rupees dropped by -0.72 percent.

In Nizamabad, a major spot market, the price ended at 12849.9 Rupees dropped by -1.71 percent.


