The markets are expected to open marginally higher today as trends in GIFT NIFTY indicate a positive start for the broader index after NIFTY closed 43 points lower at 23,696 on Wednesday.

Cyient

The company signed an MoU with Micware Navigations to collaborate on engineering services, customer introduction, and marketing strategy for intelligent mobility solutions.

Data Patterns (India)

The company reported Q3FY25 results with revenue down -16.1% YoY to ₹117 crore (†28.6% QoQ), EBITDA down -10.0% YoY to ₹54 crore (†57.4% QoQ), EBITDA margin up by +314 bps at 46.15% (†846 bps QoQ), and PAT down -32.0% YoY to ₹45 crore (†47.5% QoQ).

Datamatics
