Market Review

US: US stocks broke back into the green Wednesday, buoyed by Bank of America and Morgan Stanley's blockbuster earnings reports. Ongoing concerns about U.S.-China trade negotiations and a government shutdown weighed on investor sentiment but took a backseat to enthusiasm over a better-than-expected start to earnings season.

Asia: Most Asian stock markets extended gains on Thursday as growing expectations of imminent U.S. Federal Reserve rate cuts lifted sentiment.

India: The market ended higher on Wednesday, with the Nifty hitting a one-month peak and crossing its recent high, supported by broad-based buying across sectors. NBFC stocks were among the standout performers. Market is expected to open on a positive note and likely to witness positive move during the day.

Global economy:

Australia's unemployment rate spiked unexpectedly to a near four-year high in September as more people went looking for work, a weak result that revived hopes for more policy easing. Australia's labor market expanded less than expected in September, but picked up sharply from the previous month as more people joined the workforce, while the unemployment rate climbed to its highest level since November 2021.

The New York Empire State Manufacturing Index, a key indicator of the health of the state's manufacturing sector, has made a surprising recovery, the actual figure came in at 10.70, a significant improvement compared to the forecasted -1.80. This unexpected surge indicates a robust strengthening of the manufacturing conditions in the state, a positive sign for the overall economy.

Japan's core machinery orders fell 0.9% in August from the previous month, On a year-on-year basis, core orders, a highly volatile data series regarded as a leading indicator of capital spending in the coming six to nine months, rose 1.6%.

Commodities: Oil prices experienced a notable rise following remarks from President Trump, who announced Indian Prime Minister Modi's commitment to ceasing oil imports from Russia. This pivotal decision is poised to shake up global oil dynamics.

Gold has reached an all-time high. Investors are seeking safety due to global tensions and economic worries. Expectations of U.S. interest rate cuts and a weaker dollar are boosting gold prices. Geopolitical risks and central bank actions are also contributing to the surge. Silver prices are also climbing.

Currency: The U.S. dollar slipped on Thursday as the Sino-U.S. trade war sapped investor sentiment, while growing confidence of the U.S. Federal Reserve cutting its policy interest rate this year also weighed on the greenback.

Corporate News

Bharat Electronics secures INR 592 Cr orders since September 29. These include tank subsystems, communication systems, combat management systems, Kavach (train collision avoidance), jammers, laser dazzlers, and spares. (ET)

Jyoti Structures received an order worth Rs. 288.36 Cr. The order from AESL Projects involves the supply of towers, survey, soil investigation, foundations, erection, stringing, testing, and commissioning of a portion of the +800 kV HVDC Bhadla 3 — Fatehpur transmission line on a turnkey basis, which is to be executed in 36 months. Hero MotoCorp expands into Spain with Euro 5+ models, it has officially entered the Spanish market through a partnership with Noria Motos (part of the ONEX Group). It also introduced Euro 5+ compliant models for its international expansion. (ET)

KEC International wins INR 1,038 Cr order. It is a major order for setting up a 380 kV power substation in Saudi Arabia, enhancing its global infrastructure project portfolio. (ET)

Economy

Goods exports up 6.7% in September, trade gap widens. September was a promising month for India's exports, showcasing their vibrancy amid global turbulence. However, with imports climbing at a quicker rate, the trade deficit has widened. Ongoing discussions surrounding U.S. tariffs are under scrutiny, while negotiations for a free trade agreement with the EU are in their final stages. (ET)

India's unemployment rate rises to 5.2% in September, driven by rural job losses. Urban centers also felt the squeeze, as youth unemployment reached a concerning 3-month high. (ET)

India seeks tariff solution in US trade talks. In a strategic move towards economic collaboration, India is seeking a trade agreement with the United States that promises reciprocal advantages. Current negotiations are prioritizing the resolution of tariff discrepancies while enhancing energy trade. (ET)

International

BlackRock, Nvidia-backed group strikes \$40 billion AI data center deal. It is one of the world's biggest data center operators with nearly 80 facilities to secure coveted computing capacity for artificial intelligence. (Invst)

China's Cambricon, SenseTime shares rise on self-reliance Al venture. The two announced a partnership aimed at furthering the country's efforts for self reliance in Al infrastructure. Cambricon and Sensetime on Wednesday announced a partnership aimed at developing a "new indigenous Al development paradigm," in line with Beijing's "Al plus" strategy unveiled in August. (Invst)
