Market Review

US: US equities rose for the seventh straight day to hit fresh alltime highs on Wednesday. This is the longest winning run for the equities since November.

Asia: Stocks rose on Thursday, with markets from Tokyo to New York at record highs, while traders counted down to U.S. data that is expected to show inflation easing and pave the way for rate cuts in September.

India: The Indian benchmark equity indices logged their worst session since June 4 after hitting respective highs at open on Wednesday as shares of Mahindra & Mahindra Ltd. fell nearly 7%. Market is expected to open on a positive note and likely to witness range bound move during the day.

Global economy:

According to the Commerce Department's Census Bureau, wholesale inventories rose 0.6% as previously estimated last month. Stocks at wholesalers rose 0.2% in April. Stocks at wholesalers rose 0.2% in April. There is cautious optimism that inventory accumulation could offset some of the anticipated hit on GDP from a widening trade deficit. Growth estimates for the second quarter are around a 2% annualized rate. The economy grew at a 1.4% pace in the January-March quarter.

Ukraine's consumer price inflation quickened to 4.8% yoy in June fuelled by an increase in consumer electricity prices. Inflation was 3.3% in May yoy. Ukraine's government was forced to increase electricity prices as it hunts for funds to repair the energy system, severely hit by the Russian bombardments. As businesses increasingly use generators to produce electricity, fuel prices have also increased. The data showed that fuel prices grew by 25.5% in June yoy.

Commodities: Oil prices rose in Asian trade on Thursday, extending recent gains as weakness in the dollar ahead of key U.S. inflation data benefited price, while bets on tighter global supplies remained in play.

Gold prices firmed for a third consecutive session on Thursday, with investors awaiting U.S. inflation data due later in the day for more insights on the Federal Reserve's interest rate path.

Currency: The dollar fell a touch on Thursday although moves were largely subdued ahead of a U.S. inflation report due later in the day, while sterling firmed on receding expectations for an August rate cut from the Bank of England

Satin Creditcare Network raises 15 million euros from Development Bank of Austria

Microfinance company Satin Creditcare Network has raised 15 million euros in debt from OeEB — Oesterreichische Entwicklungsbank AG — the Development Bank of Austria. The external commercial borrowing with a tenure of five years is raised at a rate linked to Euribor and it comes around 11% approximately, a senior official with Satin said. This rate is euribor plus 260 basis points, to be precise. (BS)

GE Power India To Sell Hydro And Gas Power Business Through Slump Sale

GE Power India Ltd. is selling its hydro business and gas power business through a slump sale. The hydro business will be sold to GE Power Electronics (India) Pvt. and the gas power business will be sold to GE Renewable Energy Technologies Pvt., the company announced through an exchange filing on Wednesday. Divesting the existing businesses will help GE Power focus on service growth, retain share in service upgrades, participate in margin and cash-accretive FGD, increase the Durgapur load by supplying boiler OEM parts outside India, fabricate industrial equipment and leverage the factory's core competencies. Economy

Jute manufacturers' margins to shrink amid wage hikes and weak export demand

Jute manufacturers in India are expected to see operating margins shrink 50 basis points this fiscal due to wage hikes and subdued demand in export markets. This marks the second consecutive year of decline in profitability. However, their credit profiles will remain stable due to strong procurement by government agencies, healthy balance sheets, and negligible capital expenditure debt (ET)

International

US regulators fine Citi \$136 million for failing to fix longstanding data issues

U.S. bank regulators fined Citigroup \$136 mn for making "insufficient progress" fixing data management issues identified in 2020 and required the bank to demonstrate it was putting enough resources toward those efforts. The fines are the latest blows for CEO Jane Fraser as she tackles the bank's regulatory failings and streamlines its structure after laying off thousands of employees. The regulators fined Citi \$400 million in 2020 after identifying "ongoing deficiencies" in its handling of various areas of risk management and internal controls, including data quality management. 
