On 1st Jan 2026, US market delivered a negative performance with S&P500 down by -50.74 pts (-0.74%), Dow Jones down by -303.77 pts (-0.63%) and Nasdaq down by -212.71 pts (-0.84%). Gift Nifty grew by 24.5 pts (0.09%) indicating Indian markets will open positively.

Advance-Decline ratio on NSE was 3222:2145 and on BSE was 1669:2024 which showed balance in the overall markets.

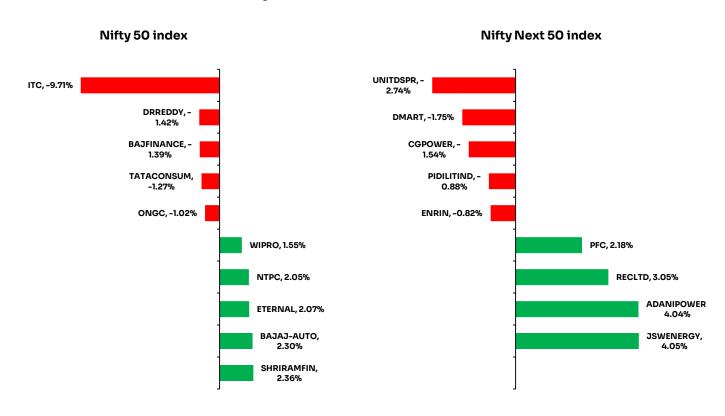

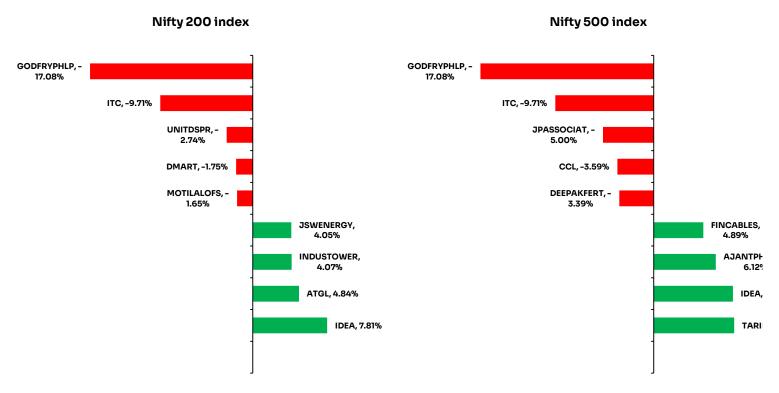
