

Market Review

US: US stocks closed broadly lower Monday as a banner year on Wall Street looked set to finish on a sour note.

Asia: Asian shares struggled for direction on the last trading day of 2024, on course for their first quarterly loss this year after a weak showing on Wall Street.

India: Benchmark equity indices ended the week's first trading session in the negative territory as weak Asian and European cues coupled with nervousness over falling rupee and renewed foreign fund outflows prompted investors to reduce equity exposure. Market is expected to open on a gap down note and likely to witness selling pressure during the day.

Global economy: China's manufacturing sector expanded in December but at a slower-than-expected pace, its third straight month of expansion as a raft of fresh stimulus measures provided support, purchasing managers index data showed on Tuesday. Manufacturing PMI was at 50.1 in December, data from the National Bureau of Statistics showed. The reading was below the 50.3 seen in the prior month, and compares with the 50.3 average forecast.

South Korea's consumer inflation quickened in December, exceeding market expectations amid a weak local currency though it was still lower than the central bank's target. The consumer price index rose 1.9% in December from a year earlier, after a rise of 1.5% in November, Statistics Korea data showed on Tuesday. It was the fastest year-on-year rise in four months and topped a median 1.7% increase forecast in a Reuters survey of economists, but weaker than the central bank's medium-term target of 2%.

Commodities: Oil prices rose in early trade on Tuesday after data showed China's manufacturing activity expanded in December, but for a second consecutive year oil was on track to end lower due to demand concerns in top consuming countries.

Gold prices were unchanged in early Asian hours on Tuesday, the last trading day of an eventful year that saw the metal post its best annual performance in more than a decade.

Currency: The dollar was firm on the last trading day of the year, poised to clock strong gains in 2024 against most currencies as investors prepared for fewer U.S. rate cuts and the incoming Trump administration's policies.

ITC to transfer Rs 1,500 cr to its demerged hotel unit for for growth and contingencies

ITC Hotels will receive ITC's trademarks under a license agreement. ITC shareholders will hold 100% of ITC Hotels - 60% directly and 40% through their existing ITC shares. The demerger is effective from January 1, 2025, and ITC Hotels' shares will be listed within 60 days of the NCLT order. (ET)

Lupin acquires Huminsulin from Lilly to enhance its diabetes portfolio

Lupin announced the acquisition of Huminsulin in India from US drugmaker Eli Lilly to further enhance its diabetes portfolio. (NDTV)

RVNL emerges L1 bidder from Central Railway

RVNL has emerged as the lowest bidder for a Central Railway project worth Rs 137.16 cr. The project involves the design, supply, erection, testing, and commissioning of a 132/55 KV traction substation in the Bhusaval-Khandwa section of Central Railway. (BS)

Promoter Nishant Pitti to sell entire 14.21% stake in EaseMyTrip via block deal on December 31

The estimated deal size is Rs 780 crore. Institutional investors are likely to participate. Pitti previously sold a 14% stake in September through open market transactions. (ET)

Economy

NPAs at 12-year low, red flags in some areas, says RBI report

The gross non-performing assets (GNPA) ratio of scheduled commercial banks declined to 2.6% in September 2024, driven by lower slippages, increased write-offs and steady credit growth. The net non-performing assets ratio improved to 0.6%, supported by robust provisioning. However, RBI has warned that the gross NPA ratio might rise to 3% by the end of March 2026 as per the baseline scenario due to risks emanating from credit quality, interest rates, and geopolitics. (ET)

Pfizer ends global collaboration with Sangamo, shares drop 27%

Sangamo's shares have seen a decrease of around 27% in response to Pfizer's decision to end the global collaboration and license agreement between the two companies. The termination of the agreement is set to take effect on April 21, 2025. Sangamo has begun exploring other options and potential partners to continue advancing its program. Pfizer's move to end the partnership is primarily due to its decision against proceeding with the Biologics License Application and Marketing Authorization Application submissions for giroctocogene fitelparvovec. (Inv)
