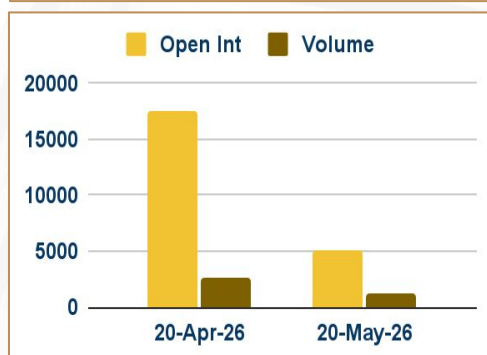

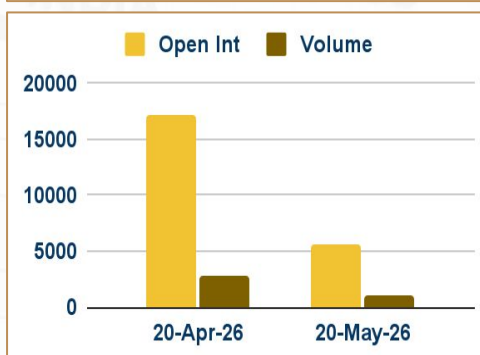

OI & Volume Chart

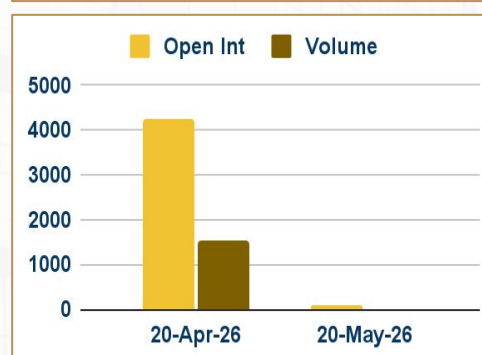

India's turmeric crop for the 2026 harvest is shaping up with higher acreage but only moderate supply growth.

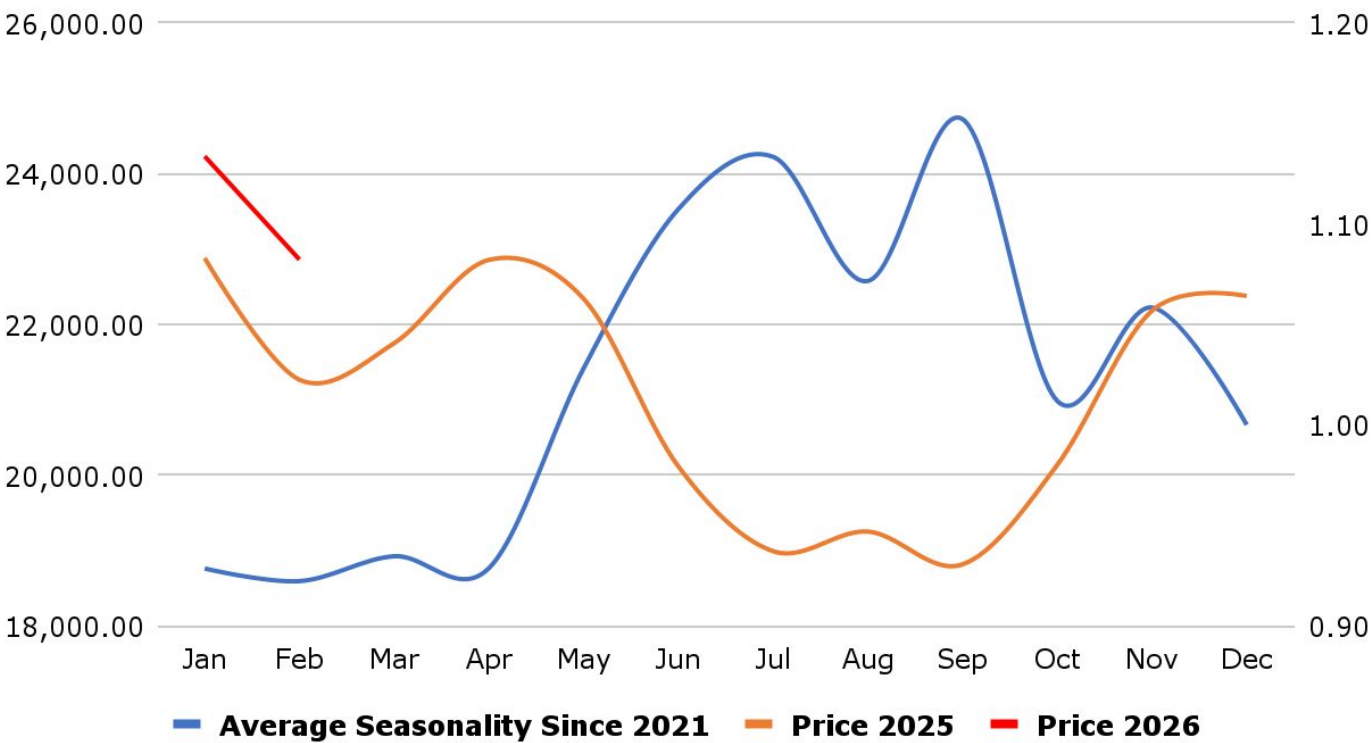
In Nizamabad, a major spot market, the price ended at 15141.8 Rupees gained by 0.27 percent.

NCDEX Jeera Seasonality

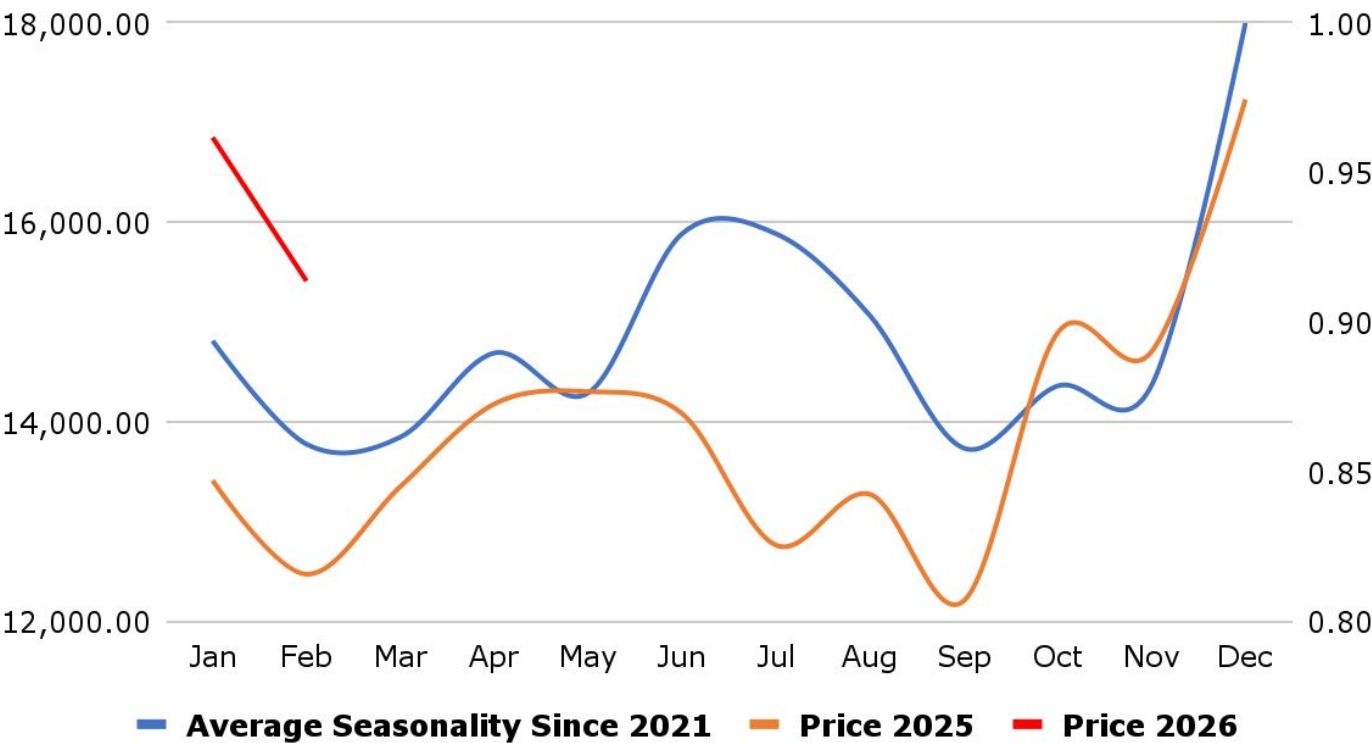


NCDEX Dhaniya Seasonality
