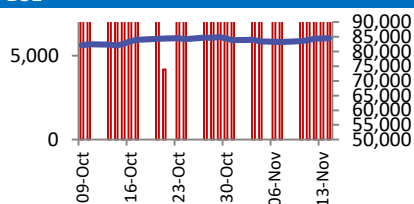
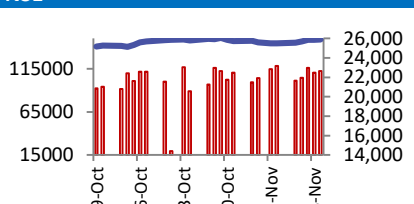

Market Review

US: US stock market ended lower on Tuesday, dragged by selling in technology stocks, with the S&P 500 putting in a fourth straight session of losses.

Asia: Asian investors battled Wednesday to kickstart a recovery in equities following the latest stagger across world markets that has been caused by worries over an AI-fuelled bubble and uncertainty over US interest rates.

India: On Tuesday, the Indian stock market ended lower, with the benchmark indices snapping their six-day winning run. **Market is expected to open on a flattish note and likely to witness range bound move during the day.**

Global economy: U.S. President Trump called for a single federal framework to regulate artificial intelligence, warning that differing state-level rules could impede investment and allow China to gain an edge.

The Donald Trump administration has been secretly working with Russia to draft a plan to end the war in Ukraine, citing U.S. and Russian officials. The U.S. is working on a 28-point plan inspired by Trump's push for a ceasefire between Israel and Hamas, and will include four main tenets.

Bank of England policymaker Swati Dhingra stated that interest rates should be reduced to their neutral level fairly soon. Dhingra was among four members of the nine-person Monetary Policy Committee who voted to lower interest rates from the current 4.0% this month, while the majority opted to maintain the current rate.

U.S. President Trump and Saudi Arabian Crown Prince Mohammed bin Salman agreed to a flurry of deals on Tuesday, the White House said, including a commitment from Riyadh to increase its investment in the U.S. to \$1 trillion.

Commodities: Oil prices fell on Wednesday as an industry report showing crude and fuel inventories rose last week in the U.S., the world's biggest crude consumer, reinforced mounting concerns that supply is exceeding demand in the market.

Gold prices were steady on Wednesday, as investors awaited minutes from the Federal Reserve's latest policy meeting and U.S. jobs report that could shed more light on the central bank's interest rate trajectory.

Currency: The yen regained its footing and the U.S. dollar held steady against most of its biggest peers in early trading in Asia on Wednesday, as investors switched into safe havens after a days-long global selloff in stocks.

Corporate News

KEC International has received notice of its exclusion from participating in tenders of Power Grid Corporation of India Limited (PGCIL) for 9 months, starting November 18, 2025. The exclusion does not affect existing PGCIL projects under execution. KEC International is evaluating available options, including legal recourse and appealing for reconsideration. The company believes this will not have a significant impact on its operations, considering its strong order book. (NDTV)

TCS has secured a five-year contract from the UK's National Health Service supply Chain to provide application development support and maintenance for its core business systems and cloud infrastructure. (NDTV)

Azad Engineering has secured a significant long-term contract with Pratt & Whitney Canada to manufacture crucial aircraft engine components. This strategic partnership, with its value undisclosed due to confidentiality, further solidifies Azad's position in the global aerospace sector. (ET)

HUL appoints Bobby Parikh as Independent Director effective Dec. 1, for five years & company's demerger of its ice-cream business into Kwality Wall's India becomes effective Dec. 1. (NDTV)

Economy

Russian crude supplies to India dropped sharply in November as refiners grew cautious following US sanctions on Rosneft and Lukoil. India-bound loadings fell two-thirds to 672,000 bpd between Nov 1-17, down from 1.88 mn bpd in Oct. Russia's overall exports also slipped, with many tankers now sailing without declared destinations as exporters seek sanction-proof routes. (ET)

Indian farmers are planting a record amount of wheat. This expansion is driven by better returns and improved soil moisture from recent rains. The increased planting is expected to significantly boost wheat production. This will help lower prices within India. It may also allow for some wheat flour exports. Farmers are shifting to wheat from other crops. (ET)

International

Whirlpool asked a U.S. trade agency to block the import and sale of microwaves from rival manufacturers based in South Korea and China, alleging they copied its patented technology for over-the-range models. (Reuters)

South Korean pharmaceutical company Celltrion, opens new tab it plans to invest up to 700 bn Korean won to expand capacity at its U.S. factory in response to U.S. tariffs and rising demand. (Reuters)

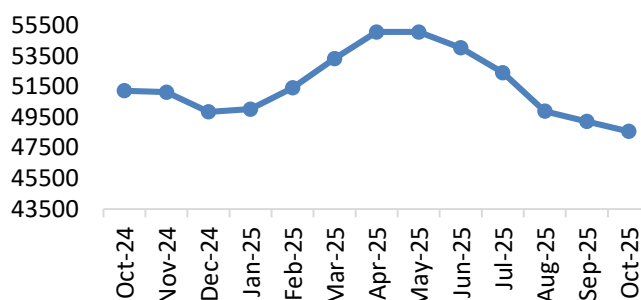
