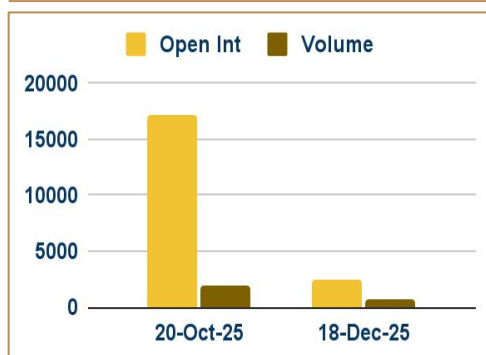

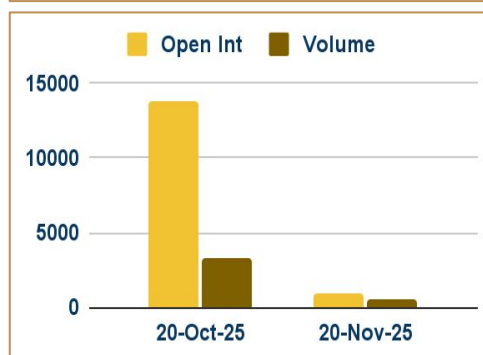

OI & Volume Chart

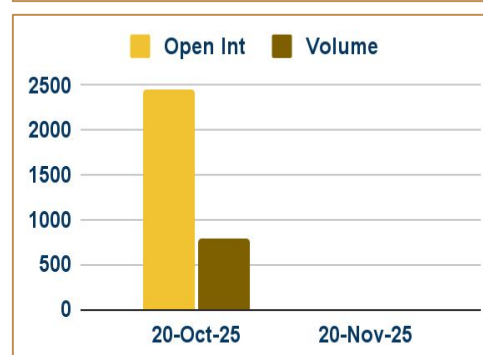

However downside seen limited after GST council lowers GST rate to 5% which will support FMCG exports & domestic demand.

In Unjha, a major spot market, the price ended at 19739.3 Rupees dropped by -0.45 percent.

Total coriander arrivals rose to 14,100 bags (each 40 kg) as against 13,100 bags in the previous session.

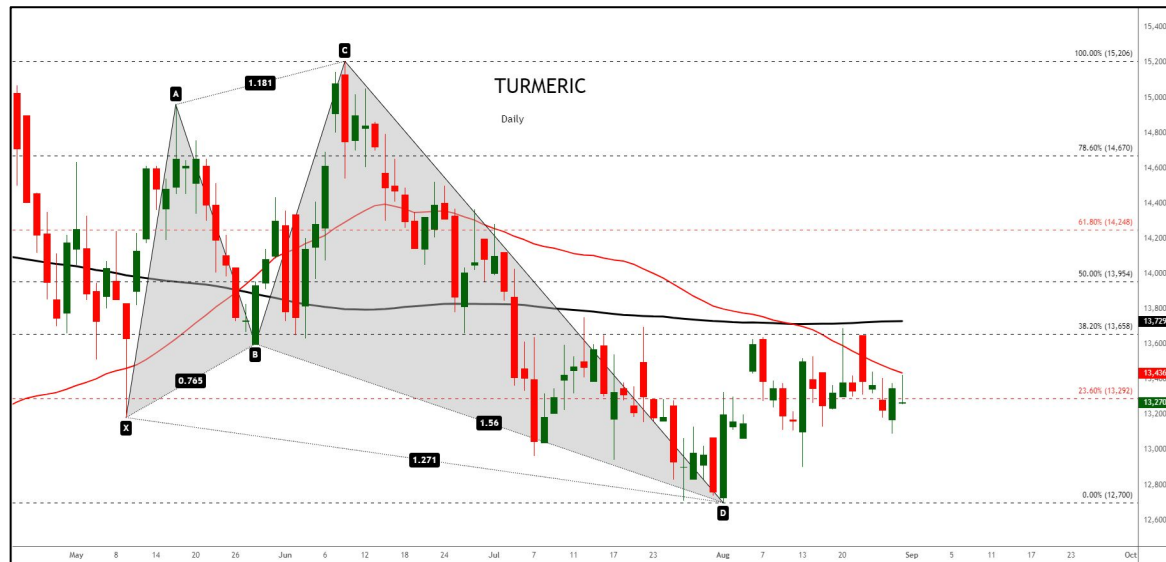
A large amount of old stock coming into the market as well as new crop weighed on prices.

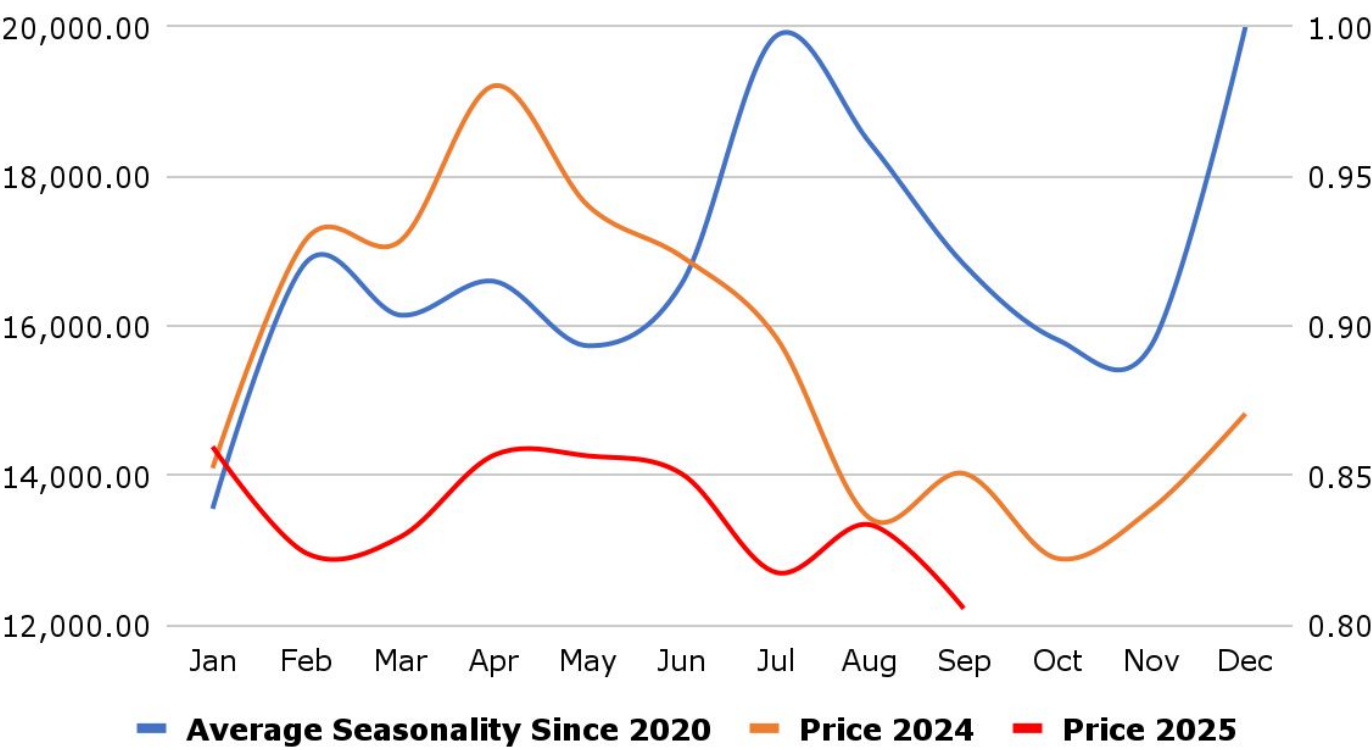
NCDEX Jeera Seasonality
