## **Market Updates**

The markets are expected to open marginally lower today as trends in GIFT NIFTY indicate a negative start for the broader index after NIFTY closed 117 points lower at 22,795 on Friday.

### **Balrampur Chini Mills:**

The company commenced India's first PLA biopolymer plant in Kumbhi, Uttar Pradesh, with a \$2,850 crore investment and 80,000 TPA capacity.

#### **Coal India:**

The company signed a non-binding SHA term sheet with EDF India to form a JV for PSP and renewable energy projects in India and nearby regions.

#### **Diamond Power Infrastructure:**

The company commenced a Medium Voltage extrusion line at Vadodara, adding 175 km/month capacity, targeting 1,350 km/month by September 2025.

#### **GNA Axles:**

The company incorporated a wholly owned subsidiary, G N A Mobility, for manufacturing auto components with an initial capital of ₹10 lakh.

## **KP Energy:**

The company commissioned a 2.8 MW wind power project at Vagra, Bharuch, increasing its IPP capacity to 48.5 MW.

#### **Lemon Tree Hotels:**

The company signed a license agreement for Lemon Tree Resort, Chittorgarh, Rajasthan, with 98 rooms, set to start operations in FY26.

#### Oil India:

The company signed an MoU with MECL to jointly explore and develop critical mineral blocks in India and overseas, including the Phop Graphite-Vanadium block in Arunachal Pradesh.

#### PI Industries:

The company partnered with C-CAMP for exclusive biocontrol technologies, AphidControl and XanthoControl, targeting major agricultural pests and diseases.

### SRF:

The company commissioned and capitalized the remaining part of its Fluorocarbon Refrigerant Gas expansion at Dahej for ₹361 crores.

## Swiggy:

The company approved an investment of ₹1,000 crores in Scootsy Logistics via rights issue for working capital and business expansion.
