The markets are expected to open marginally higher today as trends in GIFT Nifty indicate a positive start for the broader index after Nifty closed 17 points lower at 22,200 on Wednesday.

#### **HDFC Life Insurance:**

The company has declared a bonus totaling INR 37.22 billion for its policyholders.

#### **ImagicaaWorld Entertainment:**

The company has launched a new indoor air-conditioned themed attraction at Wet n Joy Amusement Park, located in Lonavala.

### **Transport Corporation of India:**

The company has declared the issuance of NCDs amounting to INR 2 billion.

### **Quick Heal Technologies:**

The company has fortified its European market presence by partnering with EET, establishing itself as the preferred distributor for cybersecurity solutions.

#### **TVS Motor:**

The company has commenced operations in Italy, offering advanced thermic and electric scooters and motorcycles through TVS Motor Italia, under the leadership of Dr. Giovanni Notarbartolo di Furnari.
