Market Review

US: U.S. stocks took a breather on Wednesday, pausing a two-day rally as the tenuous Israel-Iran cease fire continued to hold and investors pored over a second day of congressional testimony from Federal Reserve Chair Jerome Powell.

Asia: Asian stock markets are trading mixed on Thursday, as traders remain concerned about the fragile ceasefire in the Middle East that appears to hold and shift focus to the looming U.S. tariff pause deadline on July 9.

India: On Wednesday, the Indian equity markets posted strong gains amid reduced volatility and improving global sentiment. Market is expected to open on a positive note and likely to witness range bound move during the day.

Global economy: China will act more aggressively to boost laggard consumption in the country, likely heralding more stimulus measures from Beijing. China will take forceful steps to boost consumption, Li said in an address at the Asian Infrastructure Investment Bank's annual meeting. Li also highlighted resilience in the Chinese economy, and said that growth had remained stable in the second quarter. Beijing had through late-2024 rolled out a slew of measures aimed at boosting laggard consumer spending in the country, most notably subsidies on electronics and household goods.

U.S. Treasury Secretary Bessent extended the deptt's authority to continue extraordinary cash management measures to keep from breaching the federal debt ceiling by nearly a month. Bessent said in a letter to congressional leaders that he had determined that the debt issuance suspension period previously scheduled to expire on Friday needed to continue. The declaration allows the Treasury to suspend funding from govt pension and retiree healthcare funds that are not needed to pay immediate benefits.

Commodities: Oil prices inched higher, extending gains from the previous day as a larger-than-expected draw in U.S. crude stocks signalled firm demand, while investors remained cautious about the Iran-Israel ceasefire and stability in the Middle East.

Gold prices nudged higher on Thursday, supported by a softer dollar, as investors looked ahead to upcoming U.S. economic data for hints on the Federal Reserve's potential direction on interest rates.

Currency: The dollar eased to a fresh 3-1/2-year low on the euro on Thursday as concerns about the future independence of the U.S. Federal Reserve undermined faith in the soundness of the country's monetary policy.

Corporate News

Jio Financial Services infuses Rs 190 cr in Payments Bank arm JFSL has invested Rs 190 cr in its payments bank subsidiary, Jio Payments Bank Ltd, by acquiring 19,00,00,000 equity shares.

This transaction follows JFSL's recent acquisition of State Bank of India's 17.8% stake in Jio Payments Bank, making it a whollyowned subsidiary. The deal was executed at arm's length. (ET)

Vodafone Idea aims for \$2.9 bn in loans to bolster network

Vodafone Idea is in talks with lenders, led by State Bank of India, to secure approximately 250 bn rupees in loans. This funding aims to enhance its network infrastructure and improve competitiveness against Reliance Jio and Bharti Airtel. The company seeks to reclaim market share amidst subscriber losses, with potential government relief on dues possibly aiding their financial position. (ET)

SEBI slaps Rs. 25 Lakh penalty on BSE for flouting regulatory norms

Sebi slapped Rs 25 lakh penalty on BSE for failing to provide equal access to corporate disclosures to all stakeholders and take action against brokers with frequent modifications during trades. The market regulator passed the order after an inspection conducted between Feb 2021 and Sep 2022. (TOI)

Economy

FDI inflows rise to \$8.8 bn in April, NRI deposit mobilisation slows

India's foreign direct investment surged to \$8.8 bn in April, a 22% increase year-over-year, bolstering the RBI's foreign exchange reserves. While non-resident deposit inflows slowed, overall external commercial borrowing rose significantly. Despite a drop in foreign portfolio investment, India's external sector remains resilient, with forex reserves reaching \$698.95 bn in June. (ET)

After magnets, China now plants agriculture barrier for India

For the past two months, China has ceased exporting specialty fertilizers crucial for enhancing the production of fruits and vegetables to India, despite continuing shipments to other countries. This halt, impacting India's reliance on China for 80% of these chemicals, is attributed to inspections and procedural delays imposed by the Chinese government, raising concerns about potential retaliatory measures. (ET)

Microsoft, OpenAI clash over AGI clause in \$10 bln deal – The Information

Microsoft and OpenAI are facing growing tensions over a clause in their \$10 bn partnership agreement that allows OpenAI to cut off Microsoft's access to its AI models if it declares the achievement of AGI. (Invst)
