The markets are expected to open marginally higher today as trends in GIFT Nifty indicate a positive start for the broader index after Nifty closed 31 points lower at 23,259 on Monday.

NLC India:

The company has approved raising a foreign currency loan to the extent of \$600 million and has given in-principle approval to invest up to ₹9.95 billion in its unit, NLC India Renewables.
