



OI & Volume Chart





In Nizamabad, a major spot market, the price ended at 13266.25 Rupees dropped by -0.28 percent.

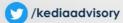
