# **Market Review**

**US:** The S&P 500 eked out a record closing high in a volatile session Friday, with interest rate-cut expectations holding up as the U.S. government shutdown went on for a third day.

**Asia:** Asian stocks hit record highs, led by Japan, while gold surged to an all-time peak and Bitcoin hovered near recent highs, as investors wagered that looser monetary policy and accelerating Al investment would boost risk appetite.

India: Indian equities closed higher for the second straight session on Friday, buoyed by optimism from the Reserve Bank of India's dovish stance and recent regulatory reforms. Market is expected to open on a negative note and likely to witness range bound move during the day.

#### **Global Economy:**

China is providing intelligence to Russia to enable Moscow to better launch missile strikes inside Ukraine, a senior Ukrainian intelligence China was passing on satellite intelligence on targets, including those benefiting from foreign investment. There is evidence of a high level of cooperation between Russia and China in conducting satellite reconnaissance of the territory of Ukraine in order to identify and further explore strategic objects for targeting.

**U.S. services sector activity stalled in September** amid a sharp slowdown in new orders, while subdued employment added to mounting evidence of sluggish labor market conditions because of sagging demand and supply of workers.

**Kuwait's non-oil private sector continued to expand in September,** but at a slower pace as growth in output and new orders weakened to one-year lows.

British business activity grew at the slowest pace in five months in September as companies and consumers put big spending decisions on hold as they waited to see if they would be hit by tax rises in November's budget.

**Commodities:** Oil prices rose about 1% in early trade on Monday after OPEC+ announced a more modest monthly increase in production than expected, tempering some concerns about supply additions.

Gold surged past \$3,900 an ounce for the first time on Monday, driven by safe-haven demand amid a U.S. government shutdown, alongside growing expectations of additional Federal Reserve rate cuts.

**Currency:** The yen tumbled against the U.S. dollar by the most in five months in early trading on Monday after Sanae Takaichi won the LDP leadership election at the weekend, setting the country on course for more expansionary fiscal policy and complicating the task facing the Bank of Japan.

#### **Corporate News**

**Ceigall India** has received Letter from Maharashtra State Electricity Distribution Co. for Solar Power Developer (SPD) for solar photovoltaic power generating stations of an aggregate capacity of 190 MW (AC) under the Mukhyamantri Saur Krushi Vahini Yojana 2.0 Scheme. (BS)

Krystal Integrated Services Limited (KISL), a leading provider of integrated facility management solutions, has secured twin contracts worth approx. ₹157 cr from the Directorate of Education, Government of NCT of Delhi. (NDTV)

India's largest manganese ore producer MOIL continued its robust growth trajectory with the highest-ever September production of 1.52 lakh tonnes, registering a growth of 3.8 per cent from the same month last year. (NDTV)

**Tata Steel** faces a new demand of ₹2,410 cr from Jajpur mining officials. This concerns an alleged chrome ore dispatch shortfall from its Sukinda block. The demand covers operations for the upcoming year. (ET)

#### **Economy**

Amit Shah announced that **15 cooperative sugar mills** will receive NCDC funding to establish compressed biogas and potash production plants. Speaking at the inauguration of a pioneering unit, he emphasized these projects mark a new chapter for India's cooperative sector.(ET)

**CBIC** has mandated a 90% provisional refund for inverted duty structure (IDS) to alleviate working capital issues for sectors like textiles. This interim measure, similar to zero-rated supplies, follows a GST Council announcement. (ET)

**UK Prime Minister Keir Starmer will visit Mumbai next week.** This marks his first official trip to India. The visit will focus on the growing economic partnership. Implementation of the free trade agreement is a key agenda item. Prime Minister Narendra Modi and Starmer will review progress. (ET)

#### International

Space tech firm Firefly Aerospace will acquire national security technology company SciTec for about \$855 mn, honing its portfolio at a time when U.S. military and civil programs are receiving increased investor interest. The deal, which will be funded through a combination of \$300 mn in cash and \$555 mn in Firefly shares. Invst)

**OpenAI and former Apple** are struggling with technical hurdles as they push to launch a new secretive artificial intelligence hardware device next year. The San Francisco start-up, led by Sam Altman, acquired Ive's design company, LoveFrom's subsidiary io, for \$6.5 bn in May. (Invst)
