


Market Review

US: US stock markets have tumbled over concerns that President Donald Trump's tariffs on Canada, Mexico and China will lead to a wider trade war and hurt the economy.

Asia: Stocks in the Asia Pacific region traded mixed early on Wednesday, on the tariff relief signal after President Donald Trump sparked a global selloff.

India: The benchmark equity indices extended their losing streak to the longest in 29 years, ending lower on Tuesday. Auto, IT, and FMCG stocks saw the steepest declines. Market is expected to open on a negative note and likely to witness range bound move during the day.

Global economy: China's services sector grew more than expected in February driven by a combination of higher domestic demand, the start-up of new projects, and promotional work, private purchasing managers index data showed on Wednesday. The Caixin services PMI came in at 51.4 in February, above expectations for a 50.8 print.

Australia's economy grew more than expected in the Q4, aided by robust public and private spending, along with a rebound in export demand. Growth also improved amid some declines in inflation, as the effects of high interest rates were felt across the economy. Gross domestic product rose 0.6% qoq. The print was higher than expectations of 0.5% and picked up from the 0.3% seen in the prior quarter.

South Korea's economy grew 0.1% in the final quarter of 2024 from the quarter before, revised central bank data showed on Wednesday, unchanged from the bank's earlier estimate. GDP expanded 1.2% on an annual basis, also the same as estimated in late January.

Commodities: Oil prices fell slightly in Asian trade on Wednesday as markets remained on edge over tariff-related headwinds and increasing global production, with focus turning to stimulus measures in top importer China.

Gold prices inched lower on Wednesday, pressured by rising U.S. Treasury yields, while investors tracked developments surrounding the possible impact of U.S. President Donald Trump's tariffs on inflation and global trade.

Currency: The U.S. dollar drooped near a three-month low versus major peers on Wednesday after the latest round of U.S. tariffs and countermeasures from Canada and China stoked fears of an escalating trade war.

Coforge Enters 13-Year, \$1.56 bn Partnership With Sabre Corp To Accelerate AI Solutions

IT solutions firm Coforge has entered into a 13-year partnership with travel technology company Sabre Corporation, according to a regulatory filing. The agreement, valued at about \$1.56 bn, will see Coforge as a key partner in helping Sabre speed up product development and launch AI solutions. (ET)

Adani Wilmar To Acquire Tops Brand Owner GD Foods

Adani Wilmar Ltd. signed a definitive agreement with GD Foods. on Tuesday to acquire the owner of household cooking brand Tops. The acquisition will take place in multiple tranches, with 80% of the shares set to be acquired in the first tranche and the rest to be acquired over the next three years. (NDTV)

ONGC Green Fully Acquires PTC Energy For Rs 925 Crore

ONGC Green Ltd., a wholly owned subsidiary of Oil & Natural Gas Corp., has acquired 65.4 crore equity shares or a 100% stake in PTC Energy Ltd. for Rs 925 crore, according to an exchange filing on Tuesday. (NDTV)

Committed to reducing regulatory burden

Finance Minister Nirmala Sitharaman emphasized India's commitment to reducing regulatory burdens and establishing trust-based governance for better ease of doing business. With over 42,000 compliance requirements removed and more than 3,700 legal provisions decriminalized, the government aims to create an export-friendly economy. (ET)

Non-tariff measures limit market access for Indian exports, says DGFT

Non-tariff measures like the European Union's carbon tax and deforestation regulations, along with aggressive industrial policies from countries like the USA and UK, are limiting market access for Indian goods. The Indian government is working on schemes to support MSME exporters, with an emphasis on credit facilities and handling non-tariff measures. (ET)

CoreWeave in talks to acquire Weights & Biases for \$1.7 bln

Cloud infrastructure provider CoreWeave is in discussions to acquire AI software startup Weights & Biases for around \$1.7 billion, The Information reported on Tuesday, citing sources familiar with the matter. The potential deal comes as CoreWeave, which provides cloud servers for AI development, prepares for an initial public offering that could value the company at over \$20 billion. (Inv)


