

US: US stocks extended declines on Thursday as the latest round of economic data failed to restart a rally and investors turned their focus to an inflation report that may shape Federal Reserve policy.

Asia: Asian stocks retreated at the open after strong US economic data and mixed signals from the Federal Reserve officials on rate cuts sparked worries about lofty valuations on Wall Street

India: India stocks were lower after the close on Thursday, as losses in the Real Estate, Power and Consumer Durables sectors led shares lower. Market is expected to open on a flattish note and likely to witness range bound move during the day. Global: President Donald Trump on Thursday unleashed a fresh round of punishing tariffs on a broad range of imported goods, saying the U.S. will impose 100% duties on branded drugs and 25% tariffs on heavy-duty trucks, among other import tariffs, starting next week. Tariffs have been a feature of Trump's second term, with duties on trading partners ranging from 10% to 50% and other targeted tariffs on a wide variety of products, casting a shadow over the global economic outlook and paralyzing business decision-making.

China's commerce ministry initiated an anti-dumping investigation into pecans imported from the United States and Mexico on Thursday, signalling more global trade tensions and increased friction with the two nations. Beijing's move came as Mexico proposed to raise tariffs on goods across multiple sectors, including textiles, steel and automotive, from China and other countries, and as China and the U.S. eye further talks in a bid to ease their trade dispute.

Commodities: Oil prices edged up on Friday, on track to rise at their steepest rate since early June as Ukraine's attacks on Russia's energy infrastructure push Moscow to restrict fuel exports and close to cutting crude output.

Gold edged lower on Friday after stronger-than-expected U.S. economic data cast doubt on the Federal Reserve's rate cut outlook and lifted the dollar, while investors awaited U.S. inflation data due later in the day for further direction.

Currency: The dollar strengthened against major peers including the euro and yen on Thursday following U.S. economic data, which would likely restrain the future interest rate cuts by the Federal Reserve.

Exide Industries invests ₹80 crore in arm to fund Bengaluru lithium-ion cell plant

Battery maker Exide Industries Limited (EIL) said it has invested ₹80 crore in the equity share capital of its wholly-owned subsidiary, Exide Energy Solutions Limited (EESL), on a rights basis. With this infusion, the company's total investment in EESL stands at ₹3,882.23 Cr. (CNBC)

State-owned Bharat Heavy Electricals Limited (BHEL) on Thursday said its board of directors has taken note of the Department of Investment and Public Asset Management's (DIPAM) decision not to approve the proposed joint venture with REC Power Development and Consultancy Ltd. (CNBC)

RITES bags \$18-million order from South Africa's Talis Logistics RITES Ltd has received a letter of award on September 25 from Talis Logistics, South Africa, for the supply and commissioning of overhauled in-service specially designed locomotives. The contract, valued at \$18 million, will be executed within 6-8 months from the receipt of advance, RITES added. (ET)

Economy

Prices of onions, pulses, cotton hit 3-year low

Prices of daily essentials such as onions, arhar, moong, and urad are trending at their lowest levels in three years, and that of yellow peas in six years. Also, soyabean and cotton prices have hit their lowest levels in two years. This comes amid a surge in imports of pulses and cooking oils, and lower onion exports, squeezing prices to multi-year lows, according to market experts. (ET)

Exporters to get 90% upfront refund only after GST law change The decision to allow 90% upfront refund for exporters under the goods and services tax (GST) framework may take time to be operationalised as the proposed revamp of the refund mechanism would require a change in the law. (ET)

Baidu eyes Australia, Southeast Asia for robotaxi expansion

Baidu is in talks with governments in Australia and parts of Southeast Asia to expand its Apollo Go robotaxi service, after reaching operational profitability on a per-vehicle basis in several Chinese cities. X'Halton Niu, general manager of Baidu's overseas intelligent driving business, the company also received 50 new trial licences in Dubai this week, doubling its United Arab Emirates fleet to about 100 cars.
