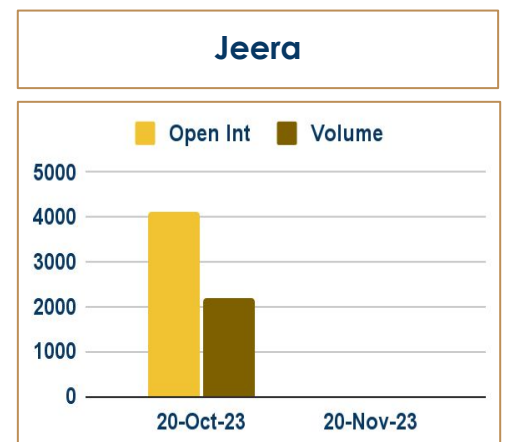
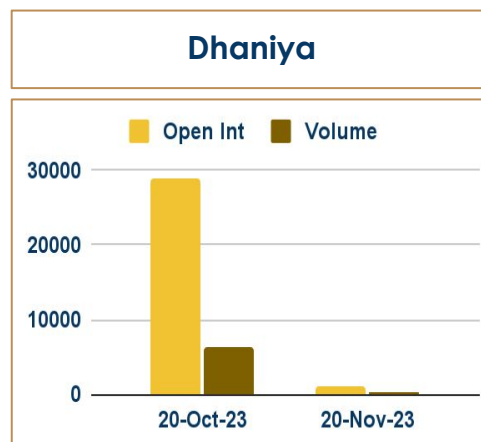
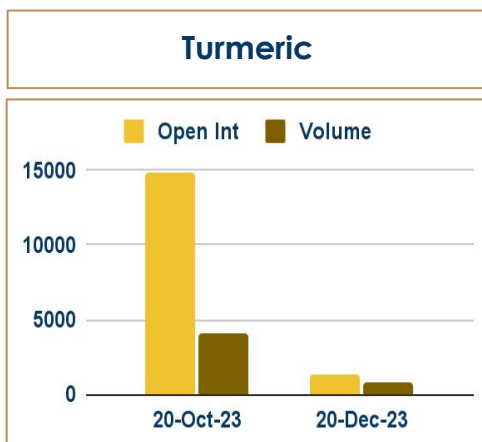

Turmeric dropped due to profit booking after prices gained as buying activities has improved.

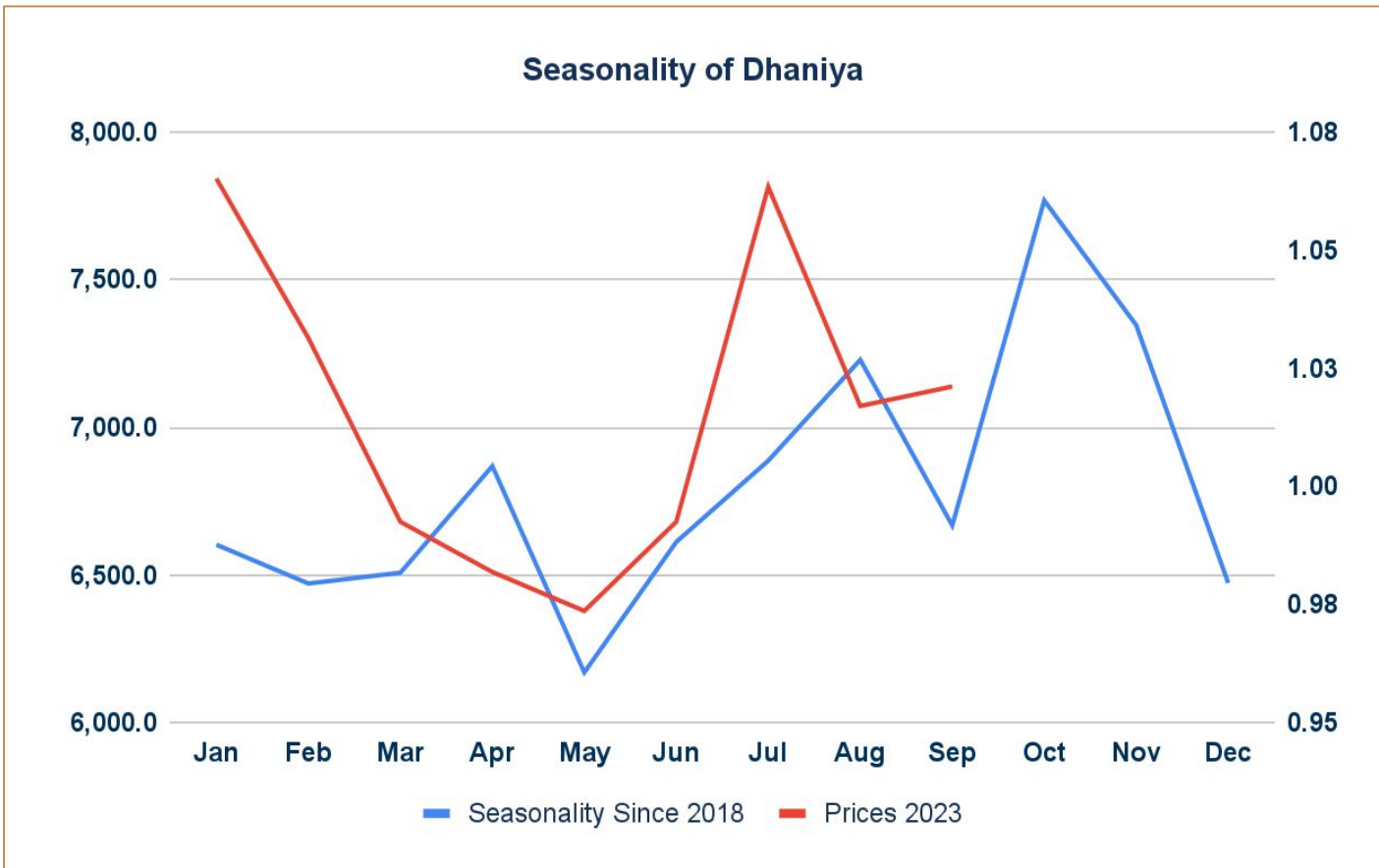
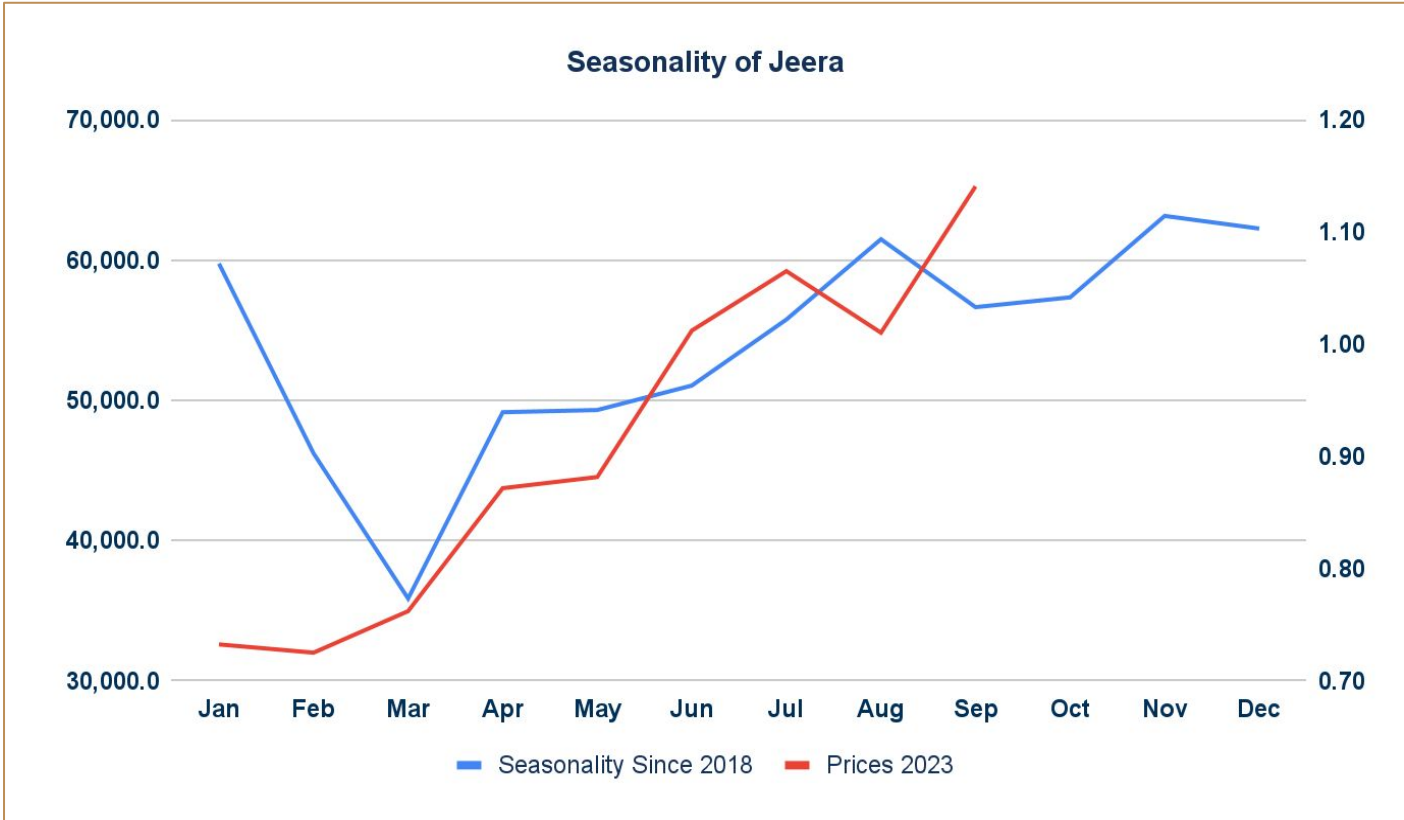

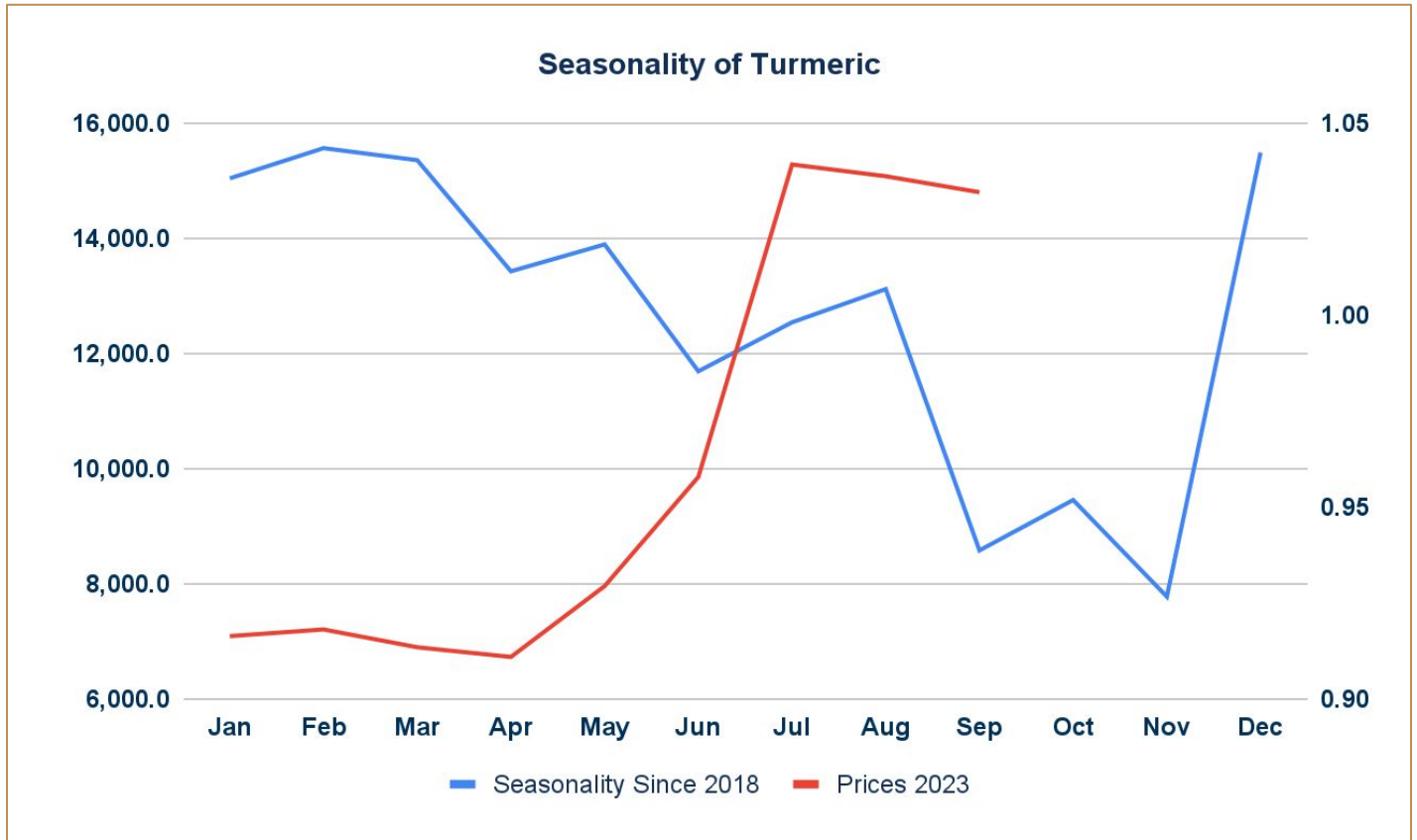
