





In Nizamabad, a major spot market, the price ended at 17483.35 Rupees gained by 0.35 percent.

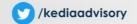
