## Market Updates

The markets are expected to open marginally lower today as trends in GIFT Nifty indicate a negative start for the broader index after Nifty closed 37 points lower at 26,178 on Friday.

## **Authum Investment and Infrastructure:**

The company is acquiring a 42.31% stake in Prataap Snacks for ₹846.60 crore and plans to launch an open offer for 62.98 lakh shares at ₹864 each, aiming to diversify its portfolio.

#### BEL:

The company has received government approval for the incorporation of a JV with Israel Aerospace Industries to provide support for the Medium-Range Surface to Air Missile system in India.

## **Bondada Engineering:**

The company has received a work order from KPI Green Energy Limited for a solar power project valued at ₹467.99 crore, to be completed within 12 months.

## **Genesys International Corporation:**

The company has secured two projects valued at ₹35 crores from NEOM Ltd and the Saudi Geological Survey Authority, focusing on geospatial technology for infrastructure development in Saudi Arabia.

## **Kitex Garments:**
