





OI & Volume Chart





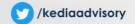

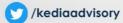

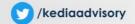

In Nizamabad, a major spot market, the price ended at 13620.05 Rupees gained by 0.16 percent.

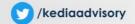
