Market Updates

The markets are expected to open marginally lower today as trends in GIFT Nifty indicate a negative start for the broader index after Nifty closed 119 points higher at 22,123.65 on Wednesday.

Bharat Heavy Electricals:

The company has received an order worth Rs 4,000 crore from Adani Power to erect a thermal power plant in Chhattisgarh.

Dr Reddy's Labs:

The pharmaceutical company has forged an exclusive distribution alliance with Sanofi Healthcare India to market and distribute SHIPL vaccine brands, encompassing established vaccines for both children and adults, across India.

GOCL Corp:

The business has inked an MoU with Squarespace Infra City, Hyderabad, for the monetization of about 264.50 acres of land in Kukatpally, Hyderabad.

NHPC:

The board has greenlit a strategy to secure Rs 6,100 crore through market loans in stages for FY25 and provisionally agreed to the discontinuation of the Loktak Downstream Hydroelectric project in Manipur, pending governmental consent.

Zaggle Prepaid Ocean Services:

The company is set to acquire a 45% share in Span Across IT Solutions, investing Rs 24.75 crore to venture into a new domain of employee-centric business.

Blue Dart:

The firm launched a 20-hour delivery service connecting major metros with GIFT City, utilizing a fleet of eight Boeing aircraft.

Shiva Cement:

The board has sanctioned a rights issue to release shares valued at Rs 400 crore.

REC:

The company has endorsed a market borrowing strategy for FY25, amounting to Rs 1.6 lakh crore, via various financial instruments.

SRF:

The company has provided corporate guarantees amounting to Rs 190 crore for its fully owned subsidiary, SRF Industries (Thailand).

Exide Industries:

The firm has infused Rs 34.99 crore into its subsidiary, Exide Energy Solutions, through a rights issue, bringing the total investment to Rs 2,000 crore.

Info Edge:

The company has committed to an investment of Rs 30 crore in Naukri Internet Services.
