Overnight global action was Positive: On 11^{th} Dec, U.S. markets up with S&P 500 +14.31 pts (+0.21%), Dow Jones up by +646.26 pts (+1.34%) and Nasdaq down by -89.05 pts (-0.35%). India VIX was down by ~3.5%. GIFT Nifty is trading up at ~26,140 (+114.00 pts, +0.5%) indicating Indian markets will open positively.

On 11^{th} Dec, advance decline ratio on NSE was 3206: 1183 and BSE was 2397:1786 which showed positive in the overall markets.






