


# **Market Review**

**US**: US stocks finished mixed on Tuesday as investors assessed fresh labor market data and continued sector rotations, leading to another cautious session on Wall Street.

**Asia:** Asian stocks opened slightly lower after weak US jobs data failed to lift expectations of further interest-rate cuts by the Federal Reserve.

India: India's benchmark indices extended losses for a third session on Tuesday, weighed down by a sharp depreciation in the Indian rupee and persistent outflows from foreign investors. Market is expected to open on a flattish note and likely to witness range bound move during the day.

**Global economy:** The nation's busiest seaport handled 11.5% less import volume in November than in the year-ago month after shippers built early inventories to avoid President Trump's tariffs on goods such as toys, auto parts and metal furniture, Gene Seroka, executive director of the Port of Los Angeles, said on Tuesday.

President Trump is scheduled to interview Federal Reserve governor Christopher Waller on Wednesday as a potential candidate for Federal Reserve chair, according to The Wall Street Journal. The interview process remains fluid, with officials noting that meetings could be postponed or canceled as Trump continues to evaluate candidates. Last week, Trump met with former Fed governor Kevin Warsh, whom he described as being at the top of his list for the position alongside Kevin Hassett, the current director of the National Economic Council.

Further interest rate cuts could put U.S. monetary policy on an accommodative footing that stimulates economic growth and risks a new jump in inflation, Atlanta Federal Reserve President Raphael Bostic said Tuesday.

# **Commodities:**

Oil prices climbed sharply on Wednesday after U.S. President Donald Trump ordered a total and complete blockade of all sanctioned oil tankers entering and leaving Venezuela, raising fresh geopolitical tensions at a time of concerns over demand.

Gold climbed on Wednesday after a U.S. jobs report showed the unemployment rate rose in November, buoying bets of further U.S. interest rate cuts next year while pressuring the dollar and yields.

### **Currency:**

The U.S. dollar weakened against major currencies following stronger-than-expected job growth data. The Federal Reserve may exercise caution in adjusting interest rates.

#### **Corporate News**

Ola Electric founder-promoter Bhavesh Agarwal undertook a one-time monetisation of a small portion of his personal stake to fully repay a Rs 260-cr promoter-level loan, leading to the release of all previously pledged 3.93% shares. Post the transaction, the promoter will continue to hold up to 34% stake, with no dilution of control or long-term conviction. The action is taken to eliminate all promoter pledges, which can introduce avoidable risk and volatility. (NDTV)

**NBCC** received an order worth Rs **345** cr. The order is worth Rs 333 cr from IIT mandi for construction of academic blocks and another order worth Rs **12** cr from Kandia SEZ for annual maintenance work. (NDTV)

Ahluwalia Contracts Received Rs 888 cr order from Bihar state tourism development Corp for EPC works. Received order for the construction of Ram Janmabhoomi tirtha Kshetra at Sitamarhi District. (NDTV)

## Economy

The Lok Sabha passed the Sabka Bima Sabki Raksha Bill, 2025 enhancing the FDI limit to 100% which will enable global insurance companies to inject substantial capital directly without waiting to seek a domestic partner, finance minister Nirmala Sitharaman said. (ET)

India is launching a major initiative to boost its manufacturing of rare earth permanent magnets. The government has approved a Rs 7,280 cr scheme to build domestic production facilities. This move aims to reduce reliance on China for crucial components. These magnets are vital for electric vehicles, electronics, and green energy sectors. (ET)

#### International

OpenAI is reportedly in talks with Amazon to raise at least \$10 bn and potentially use Amazon's AI chips as part of the deal. The discussions are said to focus on a major investment from Amazon into OpenAI. The talks underscore OpenAI's efforts to secure significant funding and diversify its access to advanced computing hardware to support the growing demands of its AI workloads. (Inv)

Spirit Aviation Holdings Inc. is in discussions to merge with Frontier Group Holdings. The potential transaction could be announced as early as December, said the sources, who requested anonymity. They cautioned that the talks are still ongoing and might conclude without an agreement. A merger would represent a major development for Spirit, which entered its second bankruptcy in less than a year when it filed in August 2025. (Inv)


