Market Updates

The markets are expected to open marginally higher today as trends in GIFT NIFTY indicate a positive start for the broader index after NIFTY closed 232 points lower at 24,363 on Friday.

Adani Enterprises

The company's subsidiary Mundra Synenergy incorporated UP Syn-Gas & Chemicals and OD Syn-Gas & Chemicals as step-down wholly owned units in India.

Adani Green Energy

The company's stepdown subsidiary commissioned a 50 MW solar-wind hybrid project at Khavda, Gujarat, raising total operational renewable capacity to 15,865.5 MW.

Goldiam International

The company received ₹40 crore export orders from clients in Middle-East, Israel and USA for lab-grown diamond studded gold jewellery.

Brigade Enterprises

The company has launched Brigade Cherry Blossom, a strategic JV in Malur (East Bengaluru), with a total development area of 4.51 lakh sq ft and projected revenue potential of over Rs 225 crore.

HG Infra Engineering

The company and DEC Infrastructure received RLDA-appointed date for ₹2,195.68 crore New Delhi Railway Station redevelopment EPC project over 45 months.

IDFC FIRST Bank

The company received RBI approval for Platinum Invictus B 2025 RSC to invest ₹2,624 crore for a 5.09% post-issue stake.

Interarch Building Solutions

The company will set up a heavy fabrication and multistorey pre-engineered steel buildings unit in AP with ₹80 crore investment.

JSW Energy

The company commissioned the final 80 MW unit of the 240 MW Kutehr Hydro Plant in Himachal Pradesh, supplying full capacity electricity to Haryana.

KPIT Technologies

The company revised Caresoft acquisition to \$157 million, raised N-Dream stake to 51%, and invested \$10 million in Helm.ai for SDV focus.

Samvardhana Motherhood International

The company incorporated a wholly owned subsidiary Motherhood New Energy to design, develop and operate renewable-based power, energy and infrastructure projects for captive use.

Zydus Lifesciences

The company received USFDA final approval for Prucalopride Tablets, 1 mg and 2 mg, with \$186.8 million US annual sales.
