US equity indices ended with little gains after latest strong job numbers weakened the hopes for a second big rate cut by the Federal Reserve.

Asian markets showed a mixed performance, reflecting varied investor sentiment across the region.

The Indian benchmark equity indices extended their fall to a third session on Tuesday as shares of heavyweights RIL and HDFC Bank weighed on them. Market is expected to open gap down note and likely to witness volatile move during the day.

Japanese markets, particularly the foreign exchanges, continue to digest the rather blunt comments on monetary policy from new PM Shigeru Ishiba after he met with Bank of Japan governor Kazuo Ueda on Wed. "I do not believe that we are in an environment that would require us to raise interest rates further," Ishiba said, sparking a huge wave of yen selling. The yen shed almost 2% against the dollar on Wednesday, its biggest fall since Feb last year. Excluding the pandemic-related volatility of March 2020, it was one of the steepest declines in over a decade.

U.S. private payrolls increased more than expected in Sep, boosted by hiring in the construction, leisure and hospitality industries, adding to the evidence of a stable labor market. There were 1.13 job openings for every unemployed person in Aug compared to 1.08 in July. Private payrolls increased by 143,000 jobs last month after rising by an upwardly revised 103,000 in Aug.

US Gold holds steady amid Middle East turmoil, eyeing US economic data Gold held steady on Thursday, as traders focused on developments in the Middle East conflict and anticipated key US economic data that may provide clues about the rate cuts expected later in the year.

Oil prices ticked higher in early trade on Thursday as investors weighed the escalating conflict in the Middle East and the potential for disruption to crude flows, against an amply-supplied global market.

The dollar rose to a one-month high versus the yen on Thursday as robustness in the U.S. jobs market backed the idea that the Federal Reserve does not need to rush to cut interest rates.

#### SBI to add 600 branches in its network during FY25

SBI plans to open 600 new branches this fiscal year to expand its reach in emerging residential areas, said its chairman and managing director CS Setty. The bank is also innovating its product offerings to attract depositors, aiming for a stronger market presence, he added. Separately, SBI is also a part of a consortium looking to auction off Rs 1,772.7 cr worth of nonperforming loans related to the Bareilly Highways Project. The auction is scheduled for Oct 30, with NARCL submitting an anchor bid that sets the stage for counter offers. (BQ)

### Adani Group merges subsidiaries with Adani New Industries

Adani Enterprises has merged its two step-down subsidiaries, Adani Infrastructure and Mundra Solar Technology, into Adani New Industries, which focuses on green hydrogen and wind turbine manufacturing. This strategic move may strengthen their position in the renewable energy sector. Separately, the company is planning a \$1.3 bn share sale to institutional investors, marking a significant move after previous setbacks. (BQ)

# Zydus gets USFDA approval to produce its generic prostate cancer drug

Zydus has received tentative approval from the USFDA to manufacture generic Enzalutamide tablets for prostate cancer treatment, which had annual sales of \$1.4 bn in the US.(BQ)

# India's September GST collection rises 6.5% YoY at Rs 1.73 lakh crore

India's GST collections in Sep reached ₹1.73 lakh cr, a 6.5% increase year-on-year. This is up from ₹1.63 lakh cr collected in the same month last year. After refunds, the net GST revenue rose by 4% to ₹1.53 lakh crore. Domestic revenue increased by 5.9% to ₹1.27 lakh cr, while revenue from imported goods grew by 8% to ₹45,390 cr. (ET)

### Amazon wins partial dismissal of US antitrust lawsuit

Amazon.com has been accused by a U.S. labor board of illegally refusing to bargain with a union representing drivers employed by a contractor, the agency announced on Wed. The complaint from the National Labor Relations Boardclaims that Amazon is a so-called "joint employer" of drivers employed by the contractor, Battle Tested Strategies (BTS), and used a series of illegal tactics to discourage union activities at a facility in Palmdale, California (Inv)
