One 97 Communication:

Paytm operator One97 Communications Ltd. has denied reports of investigation or violation of foreign exchange rules by the company or its associate Paytm Payments Bank.

Jio Financial Services:

The company has denied being in talks to acquire the crisis-hit Paytm wallet of One 97 Communications.

Zee Entertainment Enterprise:

The National Company Law Tribunal will hear on Tuesday a plea filed by the company regarding the recently terminated merger with Sony Group Corp.'s Indian subsidiary.

Adani Total Gas, INOX India:

The two companies have entered into a mutual support agreement under which ATGL and INOXCVA will mutually accord a "preferred partner" status for the delivery of LNG and LCNG equipment.

Pidilite Industries:

The company announced the inauguration of a new manufacturing facility in Sandila, near Lucknow, for its tile adhesive brand, Roff.

Triveni Turbine:

The company incorporated a wholly-owned subsidiary, 'Triveni Turbines Americas Inc.' in Texas, USA.

Styrenix Performance Materials:

The company was awarded the contract to Mott Macdonald to set up the brownfield expansion project to increase the annual capacity of ABS from 85 KT to 210 KT.

Indian Energy Exchange:

The total volume stood at 10,893 MU, up 26.1% year-on-year for the month of January.

Hindalco Industries:

The company bought a 26% stake in Ayana Renewable Power for Rs 1.63 crore.
