The markets are expected to open marginally lower today as trends in GIFT NIFTY indicate a negative start for the broader index after NIFTY closed 148 points higher at 25,001 on Monday.

## **Adani Ports**

The company's subsidiary AIPHL incorporated East Africa Ports FZCO in UAE as a step-down arm for investments in commercial enterprises and management.

## **Awfis Space Solutions**

The company approved an amendment to its MoA to add furniture manufacturing, trading, and related services to enable vertical integration and new revenue opportunities.

## **Bajaj Housing Finance**

The company raised ₹835.12 crore via NCDs (7.02%, 3-year tenure) on private placement basis for general corporate and capex purposes.

#### **Dabur India**

The company approved the amalgamation of Sesa Care with itself to strengthen its ayurvedic hair oil portfolio and enhance operational synergies.

#### Insecticides (India)

The company launched Altair, a patented pre-emergent paddy herbicide developed by Japan's Nissan Chemical, to be exclusively marketed in India.

## Lupin
