## Market Updates

**The markets are expected to open marginally higher today as trends in GIFT NIFTY indicate a positive start for the broader index after NIFTY closed 66 points lower at 25,665 on Wednesday.**

**Apeejay Surrendra Park Hotels**

The company launched Zone Connect by The Park in Patna with rooms, cottages, dining, spa, gym, pool and event spaces for up to 1,000 guests.

**BHEL**

The company commenced supply of semi-high-speed underslung traction transformers for the Vande Bharat Sleeper Train project executed by a BHEL-led consortium.

**Biocon**

The company concluded a ₹4,150 crore QIP through equity issuance to fund acquisition of minority stake in Biocon Biologics and related debt repayment.

**CEAT**

The company approved investment up to ₹32.33 crore to acquire 26% stakes in two CleanMax SPVs for ~59 MW hybrid wind-solar captive power projects.

**Kernex Microsystems**

The company received a ₹2,465.71 crore order from Chittaranjan Locomotive Works for supply installation testing and commissioning of 3,024 KAVACH loco equipment sets.

**NBCC India**

The company received a ₹55.02 crore project management consultancy order from Indian Overseas Bank for constructing its new regional office in Raipur.

**Pace Digitek**

The company received a ₹375.73 crore order from Bondada Engineering for BOS works for a 300 MW AC solar project under EPC with O&M.

**Prestige Estates Projects**
