Market Review

US: US Markets were closed yesterday on the eve of Presidents Day celebrations.

Asia: Asian shares were pinned below 1-1/2 month highs on Tuesday as even a larger-than-expected interest rate cut in China failed to excite investors jaded at the lack of bigger stimulus measures.

India: India's benchmark stock indices ended higher for the fifth straight session on Monday, with the NSE Nifty 50 hitting a fresh all-time high during the day.Market is expected to open on flattish note and likely to witness sideways move during the day

Global Economy: The People's Bank of China cut its five-year benchmark loan prime rate by a bigger-than-expected margin on Tuesday, loosening monetary conditions further in a bid to support a slowing economic recovery in the country. The PBOC cut its five-year LPR, which is used to determine mortgage rates, to 3.95% from 4.20%. Analysts had expected a cut of 10 basis points to 4.10%.

Commodities: Gold prices edged down in early Asian hours on Tuesday, pressured by a slightly stronger dollar and elevated treasury yields, while traders also awaited for further cues from the minutes of the U.S. Federal Reserve's last meeting..

Oil prices were little changed in early Asian trading on Tuesday, hovering close to three-week highs on heightened Middle East tensions and recovering China demand. Brent futures ticked down 8 cents to \$83.48 a barrel.

Currency: EUR/USD drifted back into median prices in thin Monday trading as the pair remains hampered below 1.0800. Markets opened on a quiet note with US markets dark for the US federal holiday.

Whirlpool promoter entity plans to sell up to 24% stake worth \$451 million

Whirpool Mauritius Ltd, a promoter entity of Whirpool of India, plans to sell as much as 24 percent of the local unit through a block deal for \$451 The promoter group currently owns 75 percent of the home appliance maker and had earlier indicated that it would reduce its stake in the company to reduce debt levels.

SpiceJet-Credit Suisse Case: SC says no scope for belated payment, asks carrier to clear dues by March 15

The Supreme Court directed SpiceJet to clear all outstanding dues to Credit Suisse by March 15. The court had earlier granted SpiceJet six months to settle arrears with Credit Suisse. SpiceJet, facing financial challenges, has also bid for bankrupt carrier Go First. Ajay Singh, SpiceJet CMD, has been summoned to appear before the court on March 22. (BQ)

Sugar production likely to be on a downslide in 2023-24: Industry

The overall sugar production in 2023-24 is expected to witness a downslide owing to lower rainfall, which has led to lesser sugarcane plantation this year, said the industry.AISTA estimates sugar production at 316 lakh tonnes this year as compared to 329 lakh tonnes in 2022-23.Till February 15 in the current sugar season, the production has reached 223.68 lakh tons, against 229.37 lakh tons produced last year during the corresponding period, according to Indian Sugar Mills Association

Farmers' Protest: Govt proposes various measures including MSP-related deals; farmers to respond today

In the fourth round of talks held in Chandigarh on Sunday, Union minister Piyush Goyal suggested a five-year deal with the farmers to purchase pulses and cotton at the minimum support price (MSP). However, the farmers are yet to respond on the proposals.(BQ)

Rheinmetall to open ammo factory in Ukraine in joint projectr Warren Buffett-backed U.S. consumer bank Capital One plans to acquire U.S. credit card issuer Discover Financial Services in an all-stock transaction valued at \$35.3 billion to create a global payments giant, the companies said on Monday. The deal, which is expected to receive intense antitrust scrutiny, would also form the sixth-largest U.S. bank by assets and a U.S. credit card behemoth that would compete with rivals JPMorgan Chase and Citigroup.
