


Market Review

US: On Tuesday, U.S. stocks rallied as voters headed to the polls on the last day of the presidential election and as more data piled up showing the economy remains solid.

Asia: Stock markets in Asia including that in Japan and South Korea climbed in early trade, in line with a US stock rally overnight.

India: Indian equity indices rebounded on Tuesday, driven by investor interest in undervalued financial stocks ahead of the U.S. election. Market is expected to open on a flattish note and likely to witness range bound move during the day.

Global Economy: In a surprising turn of events, the American Petroleum Institute (API) reported a significant increase in the inventory levels of US crude oil, gasoline, and distillates stocks. The actual number came in at 3.132 mn barrels, surpassing the forecasted increase of 1.800 mn barrels. This unexpected rise in crude inventories implies a weaker demand, painting a bearish picture for crude prices.

The United States' trade balance has taken a further hit, with the latest data revealing a deeper deficit than anticipated. The actual figure for the trade balance, which measures the difference in value between imported and exported goods and services, stands at -\$84.4 bn. This figure not only overshadows the forecasted deficit of -\$83.8 bn, but it also signifies a considerable increase compared to the previous reading of -\$70.8 bn. The larger deficit implies that the U.S. imported more goods and services than it exported over the reported period.

Commodities: Oil prices fell on Wednesday as early poll results in the U.S. election showed Democrat Kamala Harris and Republican Donald Trump locked in a tight race for the presidency.

Gold prices were muted on Wednesday, as investors held back from taking big positions until the U.S. election's outcome was known and shifted focus to the Federal Reserve's upcoming meeting.

Currency: The Japanese Yen stumbles against its American counterpart in reaction to the incoming US election results, triggering a sharp intraday rally.

NTPC approves Rs 80k cr investment proposals for 6,400 MW thermal capacity

Power giant NTPC on Tuesday said its board has approved investment proposals worth about Rs 80,000 crore for thermal projects totalling 6,400 MW. The board of directors has accorded investment approval for Telangana Super Thermal Power Project, Phase-II (3x800 MW) at an appraised current estimated cost of Rs 29,344.85 crore, the company said in an exchange filing. (BS)

Government To Divest Up To 2.5% Stake In Hindustan Zinc Via Offer For Sale

The Ministry of Mines has announced plans to offload up to a 2.5% stake in Hindustan Zinc Ltd. through an offer for sale. The offer will open for non-retail investors on Nov. 6 and for retail investors on Nov. 7. The floor price for the OFS has been set at Rs 505 per share, indicating a 9.8% discount to Tuesday's close, according to an exchange filing on Tuesday. (NDTV)

RVNL-Led Consortium Bags Massive ₹5,000 Cr Project From BSNL

A consortium led by RVNL and also comprising HFCL Ltd. and Aerial Telecom Solutions Pvt., has bagged a project worth Rs 5,008 crore from the BSNL. The state-run firm on Tuesday also said it has also won a construction project worth Rs 613 crore from Rail Infrastructure Development Company (Karnataka) Ltd. The share of RVNL, HFCL and Aerial Telecom in the consortium is yet to be decided. (NDTV)

Ocean freight rates increase for first time since July

Ocean freight rates across major container trading routes rose for the first time since July as the movement of goods surged ahead of the Christmas and New Year season, data shows. The Drewry World Container Index a global benchmark measuring weekly ocean freight rates across eight major east-west routes rose 4 % from the previous week to \$3,213 for a 40-foot container. According to Drewry, freight rates from China to Europe increased by 8 to 11 % between Oct 24 and 31. (BS)

International

Frontier Communications posts wider-than-expected Q3 loss, but beats on revenue

Frontier Communications Parent, Inc. reported third quarter 2024 results that missed earnings expectations but beat on revenue. Shares were trading flat following the announcement. The telecommunications company posted a loss of \$0.33 per share, wider than analysts' estimates for a loss of \$0.19 per share. Revenue came in at \$1.49 billion, topping the consensus forecast of \$1.46 billion. (Inv)
