In the month of September

Festive sales surge as GST cuts spark record demand

India's FMCG companies and retailers experienced the best Navratri sales in over a decade, with growth ranging from 25% to 100%. Reduced GST and product price cuts significantly boosted consumer sentiment, double-digit demand growth across sectors such as apparel, appliances, and food & beverages. Brands like Haier, Godrej Appliances, and Reliance Retail reported remarkable sales. Increased footfalls in malls and rising online festive shopping indicate robust consumer purchasing power ahead of Diwali and wedding season. This underscores a positive shift in consumer discretionary spending and demand recovery.

FMCG firms cut prices, increase pack sizes to pass on GST cuts

Following GST reductions effective September 22, top FMCG companies actively passed savings to consumers through price cuts and larger pack sizes. This strategy intends to capture both rural and urban markets, boosting volume and accelerating sales recovery in a competitive environment. HUL has slashed prices across products and pack sizes by INR 5- INR 76. The GST cut is also expected to shift consumer demand towards more premium products

GST 2.0 disrupts FMCG, leads to weak Q2

Demand softness and transition to GST changes disrupted FMCG sales in Q2, as distributors cleared old inventory before transitioning. Companies like Hindustan Unilever, Britannia, and Emami were impacted, with low off take and muted demand as retailers awaited clarity on new tax effective September 22. The pause is expected to reverse in Q2 due to rate reductions and increased consumer cash flow.

D2C brands double retail presence on ground

Direct-to-consumer brands expanded their brick-and-mortar footprint rapidly in September, more than doubling retail leasing share compared to last year. Consumer brands including Wow Skin Science and boAt drove this omnichannel retail surge, bridging digital and physical shopping modalities to capture more consumers, reflecting shifts in buying behaviour and new customer acquisition strategies.

RBI survey: Consumer optimism edges higher in September

Reserve Bank of India's latest inflation expectations survey indicates rising consumer confidence both in urban and rural areas. With Diwali and the festive season approaching, consumers expect easing prices due to GST cuts and improving household income, signalling potential boost in discretionary spending. The Current Situation Index, which measures how households perceive the economy today compared to a year ago, increased by 0.4 points to 96.9 in September.




Consumer PE activity (INR Bn)

- Founded in 1965, The KPN Farm Fresh is based in Coimbatore, Tamil Nadu, started as a single pushcart and has grown into one of Tamil Nadu's most recognized fresh produce and grocery chains. Known for its quality, affordability, and regional reach, it operates with a modern supply chain including large warehouses in Coimbatore and Chennai.

 - The entire capital was raised through a 100% primary issuance



M&A activity in September 2025


Consumer M&A activity (INR Bn)




