The markets are expected to open marginally lower today as trends in GIFT NIFTY indicate a negative start for the broader index after NIFTY closed 143 points lower at 25,968 on Friday.

ACME Solar

The company signed Battery Energy Storage Purchase Agreements with NHPC for 275 MW / 550 MWh to support clean energy integration and grid reliability.

BEML

The company received an order worth ₹185.65 crore from the Ministry of Defence for supply of bulldozers in regular business.

Brigade Enterprises

The company acquired a 20.19-acre land parcel in Bengaluru's Whitefield—Hoskote corridor for ₹588.33 crore through subsidiary Ananthay Properties.
