Market Review US: U.S. indices ended on a mixed note after hitting new highs ahead of data expected to underscore further disinflation, paving the way for the Federal Reserve to start cutting interest rates this year.

Asia: Asian markets mostly rose as more markets return to trade from the Lunar New Year holiday, including South Korea and Singapore.

India: India's benchmark equity indices ended lower on Monday, weighed by losses in index heavyweights HDFC Bank Ltd., ICICI Bank Ltd., State Bank of India, ITC Ltd., and Reliance Industries Ltd. Market is expected to open on a positive note and likely to witness range bound move during the day.

Global Economy: New bank loans in China jumped by more than expected to an all-time high in January, as the central bank moved to shore up the sputtering economy, reinforcing expectations for more stimulus in the coming months. Chinese lenders tend to front-load loans at the beginning of the year to get higher-quality customers and win market share. Banks extended 4.92 trillion yuan (\$683.7 billion) in new yuan loans in January, hitting a record high, up sharply from December.

German commercial property prices fell 12.1% in the final three months of 2023 compared with a year earlier in their biggestever drop, as the nation's struggling property industry suffers its worst crisis in decades. For the full year, commercial real estate prices dropped 10.2%, accelerating their decline after small drops of less than 1% in 2022 and 2021 The situation will remain difficult for the time being in 2024.

Commodities: Gold prices were stuck in a tight range on Tuesday as investors refrained from making big bets ahead of a U.S. inflation report that could give fresh perspective on how soon, and by how much, the Federal Reserve could cut interest rates this year.

Oil prices were little changed on Tuesday for a second straight day as uncertainty about the pace of potential U.S. interest rate cuts and the impact on fuel demand offset worries about Middle East tensions that could disrupt supply.

Currency: The dollar held steady on Tuesday ahead of a key U.S. inflation report that could help shape the Federal Reserve's rates outlook and determine the timing of interest rate cuts.

JSW Neo Energy awarded with 500 MW wind capacity from SECI

JSW Neo Energy, a wholly owned subsidiary of the company, has received a letter of award for a wind capacity of 500 MW from the Solar Energy Corporation of India (SECI). As per the construction of the bid, a 700 MW greenshoe option is available over the awarded capacity. This could further enhance the company's total awarded capacity by 525 MW to a maximum of 1,025 MW. (MC)

Lemon Tree to open its new hotel in Marpalle, Telangana

The company has signed a license agreement for a new hotel in Marpalle, Telangana, under its brand, Lemon Tree Resort. This hotel will be spread over 5 acres and have 50 rooms, including 14 villas, of which 5 will be water villas. This hotel is expected to be operational in FY27. (MC)

Suzlon Energy appoints Vivek Srivastava as CEO, WTG Division Vivek Srivastava has been appointed as CEO, WTG Division, reporting to the Group Chief Executive Officer of the company with effect from February 12. (MC)

Economy

India's industrial production growth rises to 3.8% in Dec from 2.4% in Nov

India's industrial production increased to 3.8% in December 2023, up from 2.4% in November, according to data from the Ministry of Statistics and Programme Implementation. Factory output growth was 5.1% in December 2022, while IIP growth was 6.1% during April-December 2023-24. Power generation and mining output declined by 1.2% YoY and 6.8% YoY respectively. The manufacturing sector saw a 3.9% YoY growth in December 2023, while capital goods and consumer durables saw growth. (ET)

India's retail inflation moderates to 5.10 per cent in January

India's retail inflation has eased to 5.10% on an annual basis, according to data released by the Ministry of Statistics & Programme Implementation. This is a decline from December's four-month high of 5.69%. A Reuters poll had predicted a threemonth low of 5.09%. The inflation rate remains within the Reserve Bank of India's tolerance band of 2-6%. (ET)

International

Ramaco Resources ups 2024 sales and production guidance

Ramaco Resources, Inc., a prominent metallurgical coal operator, announced today a significant increase in its sales and production guidance for 2024. The company has committed to sales of 3.8 million tons for the year, nearly doubling its previously forecasted figures. This updated guidance reflects a robust 90% increase since the last update in early December 2023. (INV)
