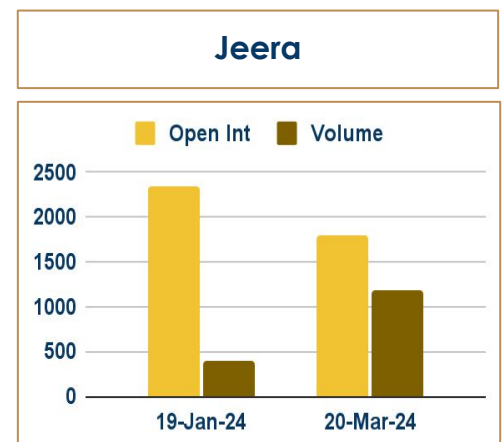
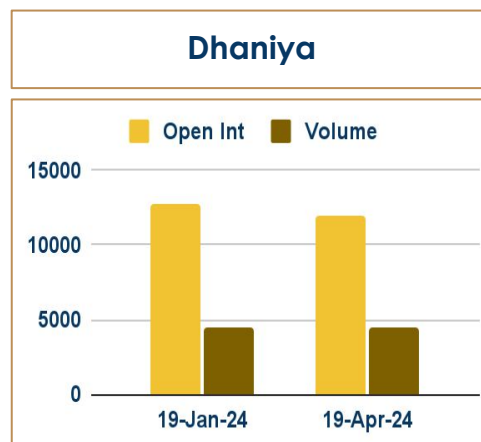
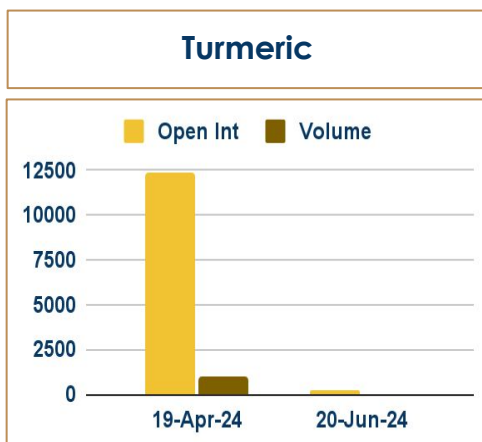

Turmeric gains due to the potential for yield losses caused by the crop's unfavourable weather.

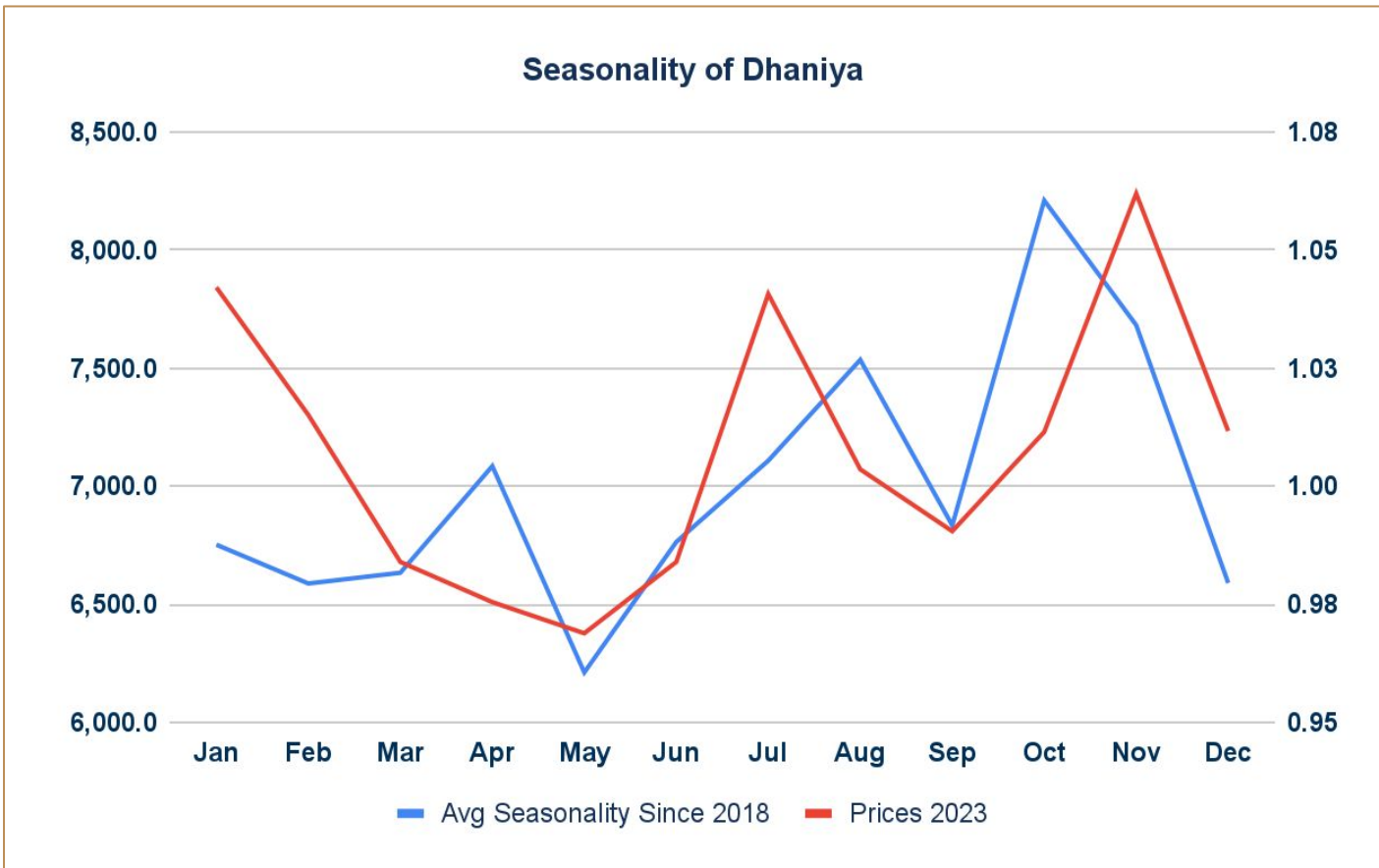
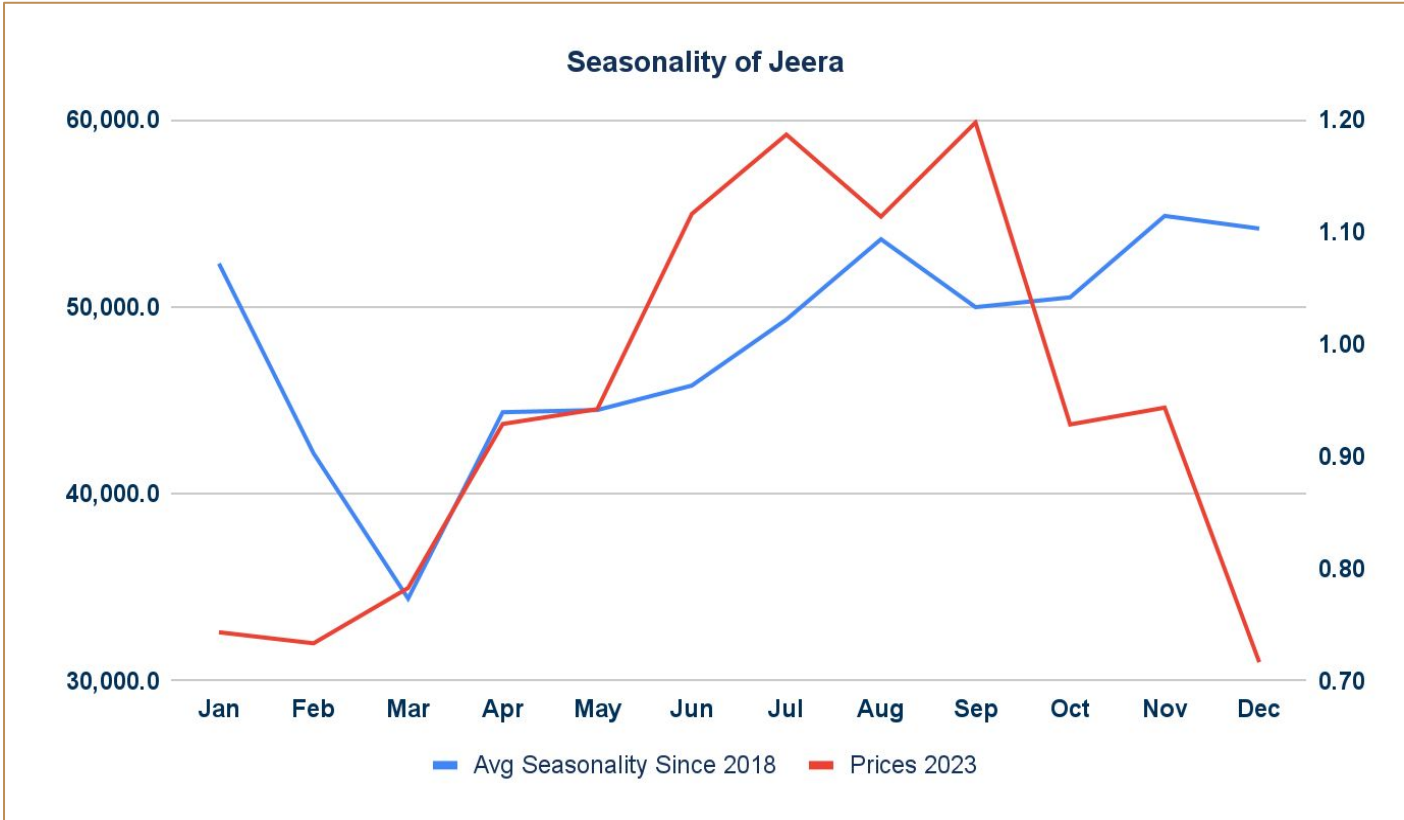
However, upside seen limited as buying activities has been slower in expectation of release of stocks.

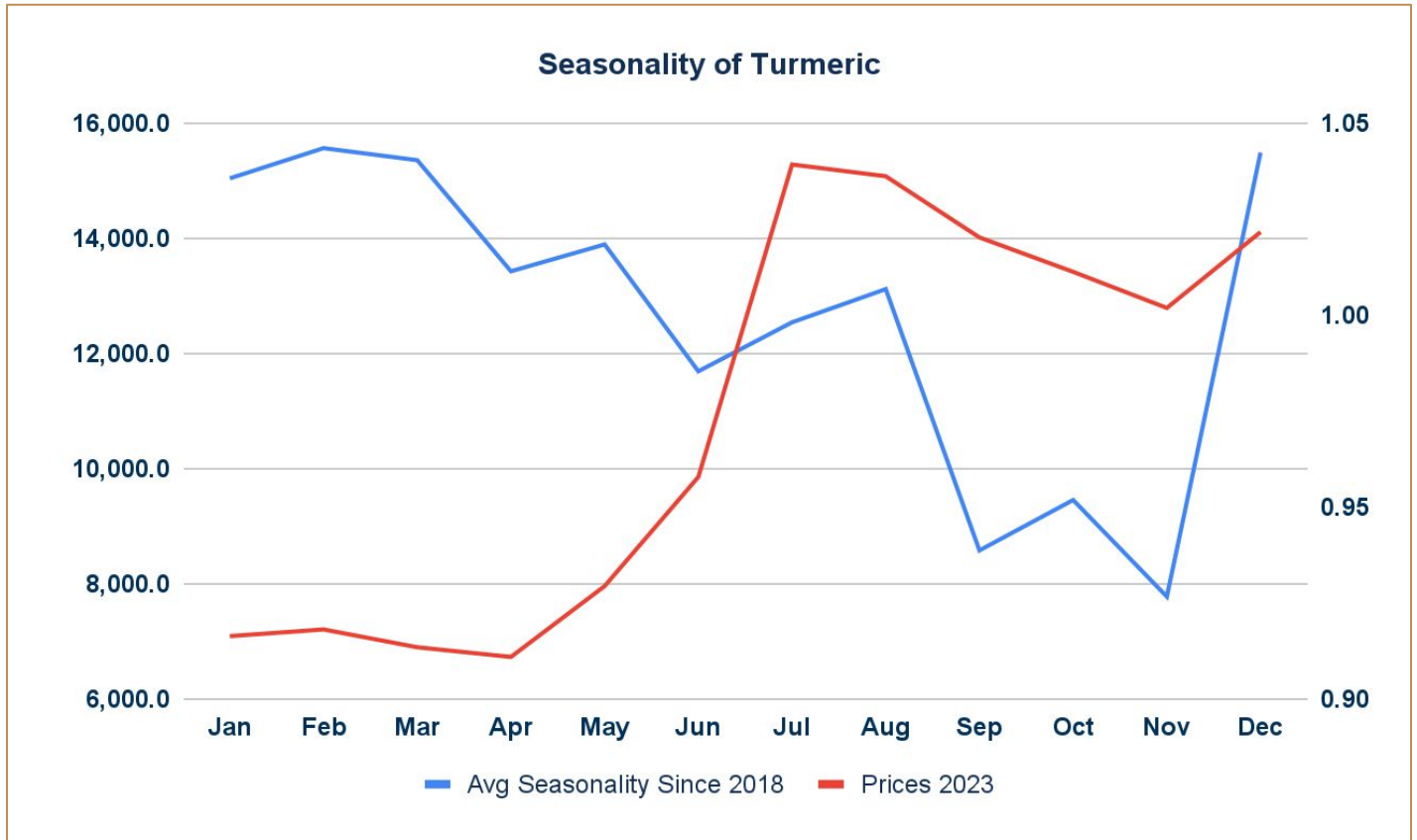
Turmeric exports during Apr-Oct 2023, rose by 2.63 percent at 1,02,162.94 tonnes as compared to Apr-Oct 2022.
