Market Review

US: US stocks ended higher on growing hopes of monetary easing.

Asia: Most markets in Asia-Pacific were trading higher on Thursday morning after the US Federal Reserve Chair Jerome Powell's comments in press conference affirmed hopes of a rate cuts as soon as September.

India: India's benchmark stock indices continued their gains for the fourth consecutive session to end at fresh record closing highs on Wednesday, ahead of the Federal Open Market Committee's meeting later in the day. **Market is expected to open on a positive note and likely to witness range bound move during the day.**

Global Economy: Brazil's central bank kept interest rates unchanged at a second consecutive policy meeting, as expected, flagging a need for "more vigilance" in monetary policy due to worsening inflation expectations and recent market swings. The bank's rate-setting committee, known as Copom, held the Selic benchmark interest rate at 10.50% in a unanimous decision. Inflation has outpaced expectations and Brazil's currency has depreciated nearly 4% since the bank's last policy meeting in mid-June, flirting with more than two-year lows amid investor concerns about fiscal discipline.

South Korea's exports rose at the fastest pace in six months in July on strong chip sales but missed market expectations, trade data showed on Thursday, amid worries about a sustained recovery in China demand. Overseas sales by Asia's fourth-largest economy rose 13.9% year-on-year to \$57.49 billion, after a 5.1% rise the previous month and marking the fastest growth since January.

Commodities: Gold prices reached a two-week high following indications from U.S. Federal Reserve Chair Jerome Powell of possible interest rate cuts by September.

Oil prices rose in early Asian trading on Thursday, extending strong gains in the previous session after the killing of a Hamas leader in Iran raised the threat of a wider Middle East conflict and on signs of strong oil demand in the U.S.

Currency: The Indian Rupee (INR) recovers on the decline of the US Dollar (USD) on Thursday.

Corporate News

Infosys under scanner for over Rs 32,000 crore GST evasion

Infosys is under the Directorate General of GST Intelligence scanner for the alleged evasion of over Rs 32,400 crore GST from July 2017 to March 2022 for non-payment of Integrated GST on import of services from overseas branches. According to an incident report filed by DGGI's Bangalore zonal unit, Infosys was expected to pay GST under the reverse charge mechanism, which requires the service recipient to pay the levy. (TOI)

Tata Steel may need to pay over Rs 17,000 cr to Odisha govt as minerals tax

Gensol Engineering Ltd on Monday said it has won the bid for 116 megawatt of solar projects in Gujarat. These Tata Steel might need to pay more than Rs 17,000 crore as minerals tax dues to the state of Odisha, if the Supreme Court rules that states can retrospectively impose taxes on mineral extraction, the company said in an exchange filing on July 31. The disclosure comes a week after a nine-judge Constitution bench of the Supreme Court by a majority held that the royalty payable on minerals under the Mines and Minerals (Development and Regulation) Act, 1957 is not a tax. Economy

Core growth drops to 20-month low of 4 per cent

The Index of Eight Core Industries -coal, crude oil, steel, cement, electricity, fertilisers, refinery products and natural gas - has a 40% weight in the Index of Industrial Production (IIP). The index was up 8.4% in June 2023. Sequentially, the output contracted 3.1% in June. "With the dip in the core sector growth, we expect the IIP to post a rise of 3.5-5.0% in June 2024," said Aditi Nayar, Chief Economist, ICRA.(ET)

International

Keppel profit inches higher, with transformation into global manager 'bearing fruit'

Singapore's Keppel on Thursday posted a rise in first-half underlying profit on upbeat performances at its infrastructure and connectivity segments, with the company moving ahead in its transition into a global asset manager. The conglomerate's net profit from continuing operations for the six-month period ended on June 30 came in at S\$513 million (\$384 million), a 7% rise from S\$481 million last year. (Inv)

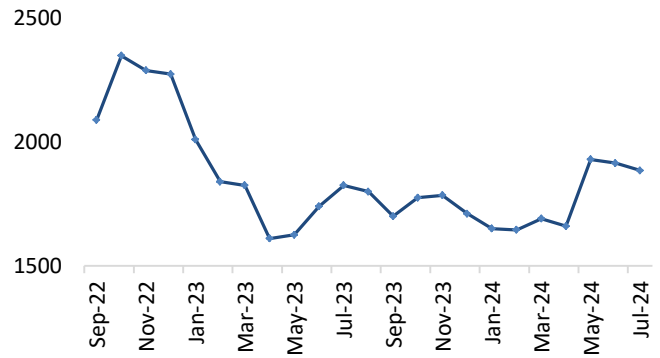
