Market Review

US: US stocks rose on Wednesday as investors reviewed a fresh round of corporate earnings following a recent losing streak on Wall Street and the jump in Apple after a White House official confirmed to that the iPhone maker is going to boost its investment in domestic manufacturing by \$100 billion.

Asia: Asia-Pacific markets rose following U.S. President Donald Trump's vow to impose a 100% tariff on imports of semiconductors and chips, but companies that are "building in the United States" will be exempted.

India: Indian benchmark indices ended lower on second consecutive session on August 6 amid volatility after RBI delivered on expected line, keeping key interest rates unchanged with 'neutral' stance. Market is expected to open on a negative note and likely to witness negative move during the day.

Global economy: Russia's national wealth fund saw its liquid assets decline to \$48.3 billion as of August 1, representing 1.8% of projected gross domestic product, the Finance Ministry announced Wednesday. This marks a decrease from the previous month when liquid assets stood at \$52.6 billion, or 1.9% of GDP.

Portugal's unemployment rate decreased to 5.9% in the second quarter of 2025, down from 6.6% in the first quarter, according to data released Wednesday by the National Statistics Institute. The latest figure also shows improvement compared to the 6.1% unemployment rate recorded in the same period last year.

Commodities: Oil prices experienced a slight rebound on Thursday, halting a five-day decline, fueled by indications of consistent demand in the U.S. market.

Gold prices saw a slight increase due to a weaker dollar, fueled by growing expectations of a Federal Reserve rate cut in the coming month. Investors are closely watching President Trump's upcoming nominations to the Fed's Board of Governors. Meanwhile, Trump imposed additional tariffs on goods from India, citing the country's import of Russian oil.

Currency: The dollar remained rangebound as investors awaited President Trump's Federal Reserve Board nominee. U.S. services sector activity flatlined in July, highlighting the impact of tariffs. Despite this, the dollar's movements were muted, with traders hesitant to take positions before the Fed announcement.

Maruti flags sluggish car sales growth; seeks policy support

Maruti Suzuki India has expressed concern over the stagnating growth in the car market, calling for urgent policy support from the govt to revive the sector. In its annual report for FY25, chairman, RC Bhargava, has pointed out that the PV industry has grown at an average annual rate of only 4.4% over the past six years. The slowdown has become more pronounced recently, with retail sales rising just 3% in FY25, followed by a 1.3% dip in the first quarter of FY26. (FE)

'The Hindi film industry has bounced back', says Sanjeev Kumar Bijli after 12% growth in footfall

PVR INOX, India's leading multiplex chain, reported a 12% year-on-year increase in footfalls in Q1 FY26, reaching 34 million patrons. Executive Director Sanjeev Kumar Bijli attributes this growth to a strong pipeline of successful domestic and Hollywood films, as well as strategic initiatives. (FE)

Shriram Life bets on pension, annuity products

Shriram Life Insurance is strategically expanding its focus on annuity and pension products, anticipating a significant market opportunity as India's elderly population is projected to more than double by 2050. (ET)

Economy

India will take actions necessary to protect national interests: MEA reacts to Trump's 'unfair' 25% additional tariff The Ministry of External Affairs reacted to Donald Trump's tariff on India. The tariff is due to India's oil imports from Russia. MEA stated that India's imports are based on market factors. The goal is to ensure energy security for 1.4 bn Indians. MEA considers the US action unfair and unjustified. (ET)

India-US spat over trade and oil threatens wider fallout Trump's trade actions against India, stemming from trade imbalances and Russian oil purchases, threaten to undermine decades of diplomatic progress. These measures, including tariffs and criticism, have strained relations, pushing India to reassess its partnerships. India faces pressure to balance its relationship with the U.S. while exploring ties with Russia and China, navigating a complex geopolitical landscape. (ET)

International

Singapore bank DBS keeps 2025 outlook, UOB trims expectations after mixed Q2 results

Singaporean banks posted mixed Q2 earnings with DBS Group maintaining its 2025 outlook and United Overseas Bank resuming guidance but trimming expectations amid macroeconomic uncertainty. DBS, Southeast Asia's largest bank by assets, reported a 1% rise in April-June net profit to \$\$2.82 bn, beating a \$\$2.77 bn average of three analyst estimates compiled by LSEG. (ET)


