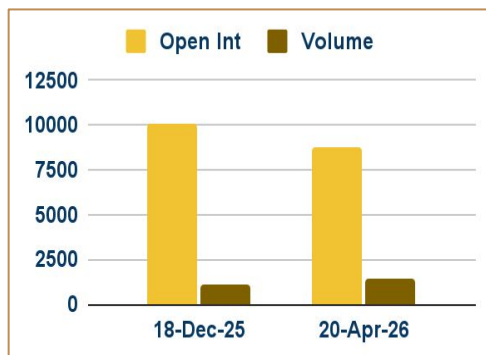

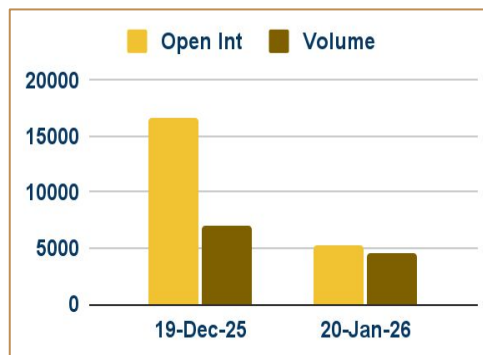

OI & Volume Chart

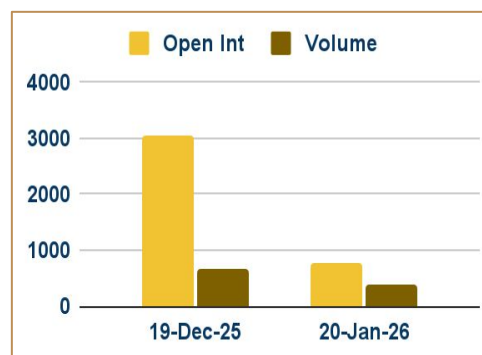

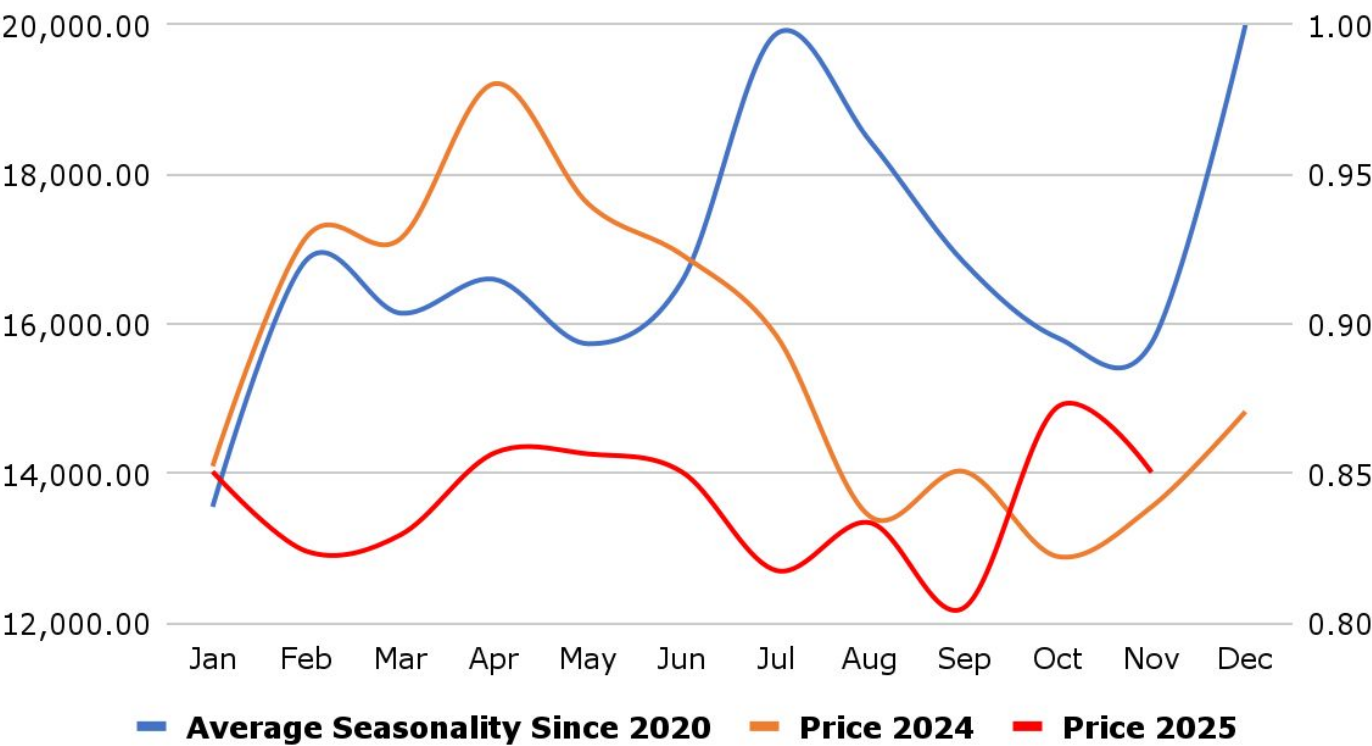
NCDEX Jeera Seasonality
