Market Updates

The markets are expected to open marginally lower today as trends in GIFT NIFTY indicate a negative start for the broader index after NIFTY closed 97 points higher at 24,967 on Monday.

Bharat Bijlee

The company approved ₹65 crore capex to expand transformer capacity at Airoli plant from 28000 MVA to 35000 MVA using internal accruals.

GlaxoSmithKline Pharmaceuticals

The company launched Jemperli and Zejula in India, introducing advanced immunotherapy and oral maintenance therapy for gynecological cancers.

Great Eastern Shipping

The company contracted to buy a 2010-built Suezmax crude carrier of 164,715 dwt, expanding its fleet to 40 vessels aggregating 3.29 mn dwt.

JK Cement

The company approved ₹4,805 crore greenfield expansion for 7 MnTPA capacity in Rajasthan and Punjab and announced key management changes.

Lemon Tree Hotels

The company signed a license agreement for Keys Select by Lemon Tree Hotels in Nashik featuring 50 rooms, a restaurant and a banquet.

NBCC

The company received Rajasthan govt approval to develop Rajasthan Mandapam Convention Centre and allied projects worth ₹3,700 crore on 95 acres RIICO land.

One 97 Communications

The company approved ₹300 crore infusion into Paytm Money, ₹155 crore into Paytm Services, restructuring Foster Payment for ₹61 crore, and transferring First Games for ₹140 crore.
