## Bullion

Gold prices dragged lower in the last session after the elevated CPI data which dragged prices lower. The prospect of rate hike has increased this year which can act as a catalyst for Gold prices and it may dent its sentiments in coming weeks.

## NYMEX Oil

Oil prices edged lower on Wednesday, after earlier hitting a 10-month high, as a surprise build in U.S. crude inventories offset expectations of tight crude supply for the rest of the year. International benchmark Brent futures dipped 18 cents to settle at \$91.88 a barrel. Its session high of \$92.84 a barrel was the highest since November.U.S. West Texas Intermediate crude (WTI) dropped 32 cents lower to \$88.52. Its session high of \$89.64 a barrel was also the highest since November.

## Copper

Copper prices closed higher after the CPI data and also there was an input that Shenzhen has further eased Home buying curbs to boost demand. Shenzhen, one of China's biggest cities, has further relaxed home buying eligibility criteria in the latest series of measures to prop up the local housing market, according to a Caixin report, citing people familiar with the matter.
