### Comments:

Nifty weekly contract has the highest open interest at 23500 CE and 22000 PE while monthly contracts have the highest open interest at 23500 CE and 22000 PE. The highest OI addition was seen at 23000 CE and 21500 PE in weekly and at 22500 CE and 21500 PE in monthly contracts. FILs increased their future index long holdings by 7.98%, increased future index shorts by 4.69% and in index options, 12.20% increase in Call longs, 1.08% increase in Call short, 9.58% increase in Put longs and 1.93% increase in Put shorts.
