



MARKET REVIEW


- Equity benchmark indices ended Tuesday's session largely flat and volatile.

- The S&P BSE Sensex declined 42.64 points or 0.05% to 85,524.84. The Nifty 50 index rose 4.75 points or 0.02% to 26,177.15.

BANK NIFTY FUT CHART




NIFTY FUT TECHNICAL OUTLOOK

- Nifty is expected to open on a flattish note and likely to witness range bound move during the day.
- On technical grounds, Nifty has an immediate Resistance at 26270. If Nifty closes above that, further upside can be expected towards 26350-26440 mark.
- On the flip side 26120-26040 will act as strong support levels.

BANK NIFTY FUT TECHNICAL OUTLOOK

- Bank Nifty is expected to open on a flattish note and likely to witness range bound move during the day.
- Bank Nifty's next immediate resistance is around 59600 levels on the upside and on a decisive close above expect a rise to 59800-60000.
- There is an immediate support at 59250-59100 levels.
