





In Nizamabad, a major spot market, the price ended at 13584.25 Rupees gained by 4.31 percent.

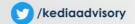
