Eligibility Criteria for Applying the Scholarships

- The candidate should secure 90% or equivalent grading in the qualifying examination (+2)
- The family income of the applicant should not exceed INR 2 lakhs per annum.
- The candidate should qualify the relevant entrance examination and should have obtained admission in a recognized educational institution.

Each selected MBBS student will receive a total scholarship of ₹2,40,000, while students pursuing B.Tech and B.Sc Nursing will be granted ₹1,20,000 each, covering the four-year course duration. 10 students from each stream - MBBS, B.Tech, and B.Sc Nursing (total of 30 students) will be selected for the scholarships from every location.

Now entering its ninth edition, the Muthoot M George Higher Education Scholarship stands as a testament to the company's unwavering commitment to promoting access to higher education and empowering India's youth through inclusive and equitable opportunities for learning.
