## **Market Review**

**US:** U.S. stock futures were little changed on Tuesday night, following a volatile session for stocks, as traders digested the latest developments in the U.S.-China trade war.

**Asia:** Asian stocks rebounded after three days of losses, as optimism over a potential Federal Reserve rate cut lifted sentiment and outweighed renewed US-China trade tensions.

India: Indian benchmark indices reversed early gains to close lower for a second consecutive session on Tuesday, with a retreat in financials weighing on sentiment. Market is expected to to open on a positive note and likely to witness positive move during the day.

#### Global economy:

Chinese consumer price index inflation shrank as private consumption showed few signs of recovery amid weak economic conditions, with producer inflation falling for a third straight year. CPI inflation shrank 0.3% year-on-year in September. The print was weaker than expectations for a drop of 0.2%, but improved slightly from the 0.4% seen in the prior month.

**U.S. small-business sentiment declined in September** amid expectations of unfavorable operating conditions in the next six months, and many owners reported raising prices or planning to, suggesting that inflation was poised to increase further. The Small Business Optimism Index dropped 2.0 points to 98.8 last month. It was the first decline in three months.

British grocery inflation rose to 5.2% in the four weeks, adding to pressure on consumers already facing higher energy bills. Higher employer taxes and regulatory costs as well as increased staff wages are adding to inflationary pressure from higher prices for commodities.

**Commodities: Oil prices are dropping**. The International Energy Agency warns of a potential surplus of 4 million barrels per day in 2026. This is due to increased output from producers and sluggish demand. Trade tensions between the United States and China are also a concern.

**Gold prices surged**, nearing record levels. Investors sought safety in bullion as U.S.-China trade tensions escalated, increasing global uncertainty. Expectations of further U.S. interest rate cuts also fueled the rally. Silver prices also climbed, tracking gold's upward movement.

**Currency: The US dollar faced pressure**, Federal Reserve Chair Jerome Powell's comments fueled expectations of an interest rate cut this month. Meanwhile, trade disputes between Washington and Beijing escalateds, impacting currency markets.

## **Corporate News**

The Board of Hyundai Motor India has approved the Succession Plan for the MD of the company. Unsoo Kim, the current MD, will return to South Korea to take on a strategic role at the Company, effective 31 Dec'25. Tarun Garg, presently serving as Whole-time Director, will succeed Unsoo Kim as the MD & CEO of the company, effective 1 Jan'26. (MC)

**'LG Electronics to deepen roots in India', said William Cho, Global CEO.** It Launches Essential Series, a range of products designed in India for India. The Essential Series range starts at INR 18,000 and includes white goods from refrigerators to microwave ovens. It would for value-conscious customers in the country, providing white goods at affordable prices. (BL)

Vedanta's INR 17,000 Cr acquisition of Jaiprakash Associates gets CCI nod. Vedanta had emerged as the highest bidder for JAL. Vedanta plans to make an upfront payment of about INR 3,800 Cr, followed by annual payments of INR 2,500-3,000 Cr over the next five years. (ET)

Saatvik Green Energy secures INR 639 Cr solar module orders. The orders were placed by three independent power producers and EPC companies and are scheduled to be executed by Jun'26. Additionally, it has received another order worth INR 50.62 Cr from renowned independent power producers/EPC for the supply of solar PV modules. (CNBC)

## **Economy**

India's fintech revolution has expanded access to credit. FM Nirmala Sitharaman highlighted fintech's role in financial inclusion and digitising credit access, while also emphasising India's self-funded green transition amid global energy challenges. (ET)

**IMF** raises India's FY26 growth forecast to 6.6%, cites strong Q1 momentum. India's economy expanded 7.8% in Q1FY26, the fastest pace in over a year and is likely to log around 7% growth in the Q2 as well. The IMF attributed the upward revision to resilient domestic demand, robust service exports, and the carryover effect from the strong start to the fiscal year. (MC)

## International

**GM to take \$1.6 Bn charge in Q3 as tax credit blow muddies EV plans**, as it reshapes its electric vehicle strategy following the scrapping of a key federal incentive that is likely to dampen demand. (Invst)

Intel signals return to AI race with new chip to launch next year. It announced a new artificial intelligence chip for the data center that it plans to launch next year, in a renewed push to break into the AI chip market. (Invst)
