The markets are expected to open marginally higher today as trends in GIFT NIFTY indicate a positive start for the broader index after NIFTY closed 429 points higher at 22,828 on Friday.

Ahluwalia Contracts (India) Ltd

The company received a ₹396.5 crore domestic housing project order from Godrej Properties for construction at Godrej Riverine, Noida, to be executed in 25 months.

Aurobindo Pharma Ltd

The company received 11 procedural observations from USFDA for its Raleigh plant.

CEAT Ltd

The company approved a ₹3.45 crore rights issue investment in its wholly owned subsidiary Tyresnmore, maintaining 100% shareholding in the auto ancillary firm.
