

Market Review

US: Global shares pushed higher on Friday, adding to weekly gains, after encouraging U.S. economic data helped soothe fears of a recession in the world's largest economy.

Asia: Asian markets mostly rose Monday following last week's strong performance, with traders focused on a closely followed meeting of central bank chiefs where the Federal Reserve's Jerome Powell is due to deliver a key speech.

India: Benchmark equity indices ended with weekly gains after two consecutive weeks of losses. Both the Nifty and Sensex recorded their highest closing since Aug. 2 on Friday as shares of financials and technology companies led the gains. Market is expected to open gap up and likely to witness positive move during the day.

Global economy: Israel's economy grew less than expected in the second quarter of 2024, extending a period of volatility since the start of war in Gaza, but the weakness is likely not enough to prompt a central bank rate cut next week given rising inflation. The Central Bureau of Statistics said in an initial estimate on Sunday that GDP grew by an annualised 1.2% in the April-June period. Overall growth was led by gains in consumer spending (12%), investment in fixed assets (1.1%) and government spending (8.2%), offsetting an 8.3% decline in exports. First-quarter GDP was revised to 17.3% annualised from a prior estimate of 14.4%, bouncing back from a contraction of 20.6% in the fourth quarter of 2023. Over the first half of 2024, Israel's economy grew 2.5% at an annual rate versus 4.5% in the same period in 2023, according to the statistics bureau.

U.S. single-family homebuilding dropped to a 16-month low in July, likely weighed down by Hurricane Beryl and an oversupply of new houses as higher mortgage rates and prices depress sales. The fifth straight monthly decrease in homebuilding reported by the Commerce Department on Friday suggested the housing market remained subdued at the start of the third quarter.

Commodities: Oil prices eased in early Asian trading on Monday as fears of weaker demand in top oil importer China weighed on market sentiment while investors focus on the progress of ceasefire talks in the Middle East, which could reduce supply risks.

A softer dollar combined with lower bond yields to help gold hold at \$2,506 an ounce, and near an all-time peak of \$2,509.69.

Currency: The U.S. dollar was struggling to make headway against its peers on Monday, though it traded in a tight range as investors awaited fresh catalysts this week that could offer clues on the outlook for U.S. interest rates.

Jubilant Pharmova to invest in MNC Pierre Fabre's French R&D centre via new unit

The company's unit, Jubilant Biosys, will add drug discovery and preclinical development capabilities. Capabilities to be added via a new company incorporated in France, which will acquire Pierre Fabre's R&D Centre in the country. The company is to invest up to €14.4 million over seven years, including €4.4 million for an 80% stake in the new company. (ET)

Escorts Kubota eyes land in UP for Rs 4500 cr manufacturing facility after pivot from Rajasthan

Escorts Kubota has announced plans to build a Greenfield manufacturing facility in Uttar Pradesh, seeking land acquisition approval from the state government. With an investment of Rs 4,500 crore, the company aims to generate annual revenue of Rs 10,000 crore and create 14,000 jobs upon completion. The plan is subject to necessary clearances. Economy

India facing acute shortage of natural rubber, prices soar

India is experiencing a significant shortage of natural rubber (NR), with domestic production lagging behind demand by approximately 5.5 lakh tonne. Despite an increase in NR production from 8.39 lakh tonne in 2022-23 to 8.57 lakh tonne in 2023-24, consumption has surged from 13.5 lakh tonne to 14.16 lakh tonne, maintaining the large deficit. This situation has led to importing challenges due to high customs duties and availability issues, resulting in soaring prices and a potential crisis for industries reliant on NR.(ET)

Cabinet approves metro rail projects worth Rs 30,000 crore in Bengaluru, Thane, and Pune

The Union Cabinet sanctioned metro projects in Bengaluru, Thane, and Pune, totaling Rs 30,000 crore and set for completion by 2029. New civil enclaves at Bagdgora Airport and Bihta, Patna, costing nearly Rs 3,000 crore, were also approved to tackle airport capacity issues in West Bengal and Bihar.(et)

International

South Korean AI chip makers Rebellions and Sapeon agree to merge

South Korean artificial-intelligence chip makers Rebellions Inc and Sapeon Korea Inc have signed a definitive merger agreement, the privately held companies said on Sunday. They announced merger negotiations in June. The deal is the latest attempt by South Korean companies to challenge global AI chip leaders such as Nvidia. Sapeon's shareholders include South Korea's largest telecom company SK Telecom and the world's second-largest memory chipmaker SK Hynix.
