

Market Review

US: U.S. stocks hit all-time highs in the run-up to the U.S. jobs report, with investors betting some of the world's major central banks will start slashing interest rates as soon as June

Asia: Markets in Asia-Pacific region were trading in negative, taking cues from decline on Wall Street as investors assess Japan's GDP data, and await U.S. CPI print.

India: India's benchmark stock indices ended at a fresh record closing high in a truncated week on Thursday, led by gains in the shares of Bajaj Auto and Bharti Airtel. Market is expected to open on a positive note and likely to witness sideways move during the day

Global Economy: Japan's economy avoided a technical recession, revised government data showed on Monday, even though the upward change in the fourth quarter was weaker than expected and highlighted concerns about the sluggish economic recovery. Japan's revised gross domestic product expanded at an annualised clip of 0.4% in the October-December period from the previous quarter, better than the initial estimate for a 0.4% contraction, according to the Cabinet Office.

The European Central Bank left interest rates unchanged for a fourth meeting as a softer outlook for inflation and economic growth bolstered expectations for cuts starting in June. Separate data showed the euro-area economy stagnated at the end of last year, underscoring the central bank's forecast for slower growth in 2024 than previously estimated.

Commodities: Gold prices rose on Monday, and hovered near a record peak hit in the previous session, as remarks from Federal Reserve Chair Jerome Powell and U.S. economic data last week cemented hopes for a rate cut in June.

Oil prices extended last week's losses on Monday on concern about slow demand in China, though lingering geopolitical risk surrounding the Middle East and Russia limited the decline. Currency: The yen strengthened against the dollar on Monday as signs the Bank of Japan will exit negative interest rates at its policy meeting next week contrasted with expectations for the Federal Reserve to cut rates in June.

$\mbox{\rm GAIL, ONGC}$ & Shell sign $\mbox{\rm MoU}$ to explore opportunities for ethanol import

State-run GAIL has signed a tripartite Memorandum of Understanding with Oil and Natural Gas Corporation and Shell Energy India to explore opportunities for import of ethane and other hydrocarbons. Economy

States' capex focus pivots away from roads to social services

Indian States are expected to reduce their capital expenditure on roads in FY25, focusing more on social services like public health and education. This shift is partly due to the post-pandemic realization of the need to develop human capital. States are also aiming to meet their fiscal targets, with some compromising on road spending to achieve this. While overall spending on roads by states is set to increase, the growth rate is slowing down compared to previous years.(ET)

International

Delta expects Boeing 737 Max 10 may be delayed until 2027

Delta Air Lines Inc expects the deliveries of Boeing Co's 737 Max 10 aircraft to be pushed out to as late as 2027, as the planemaker faces federal safety and criminal reviews. The airline announced in July 2022 that it would buy 100 Boeing 737 Max 10 jets worth about \$13.5 billion at list prices and has options to buy another 30 and was looking to begin receiving the planes in 2025
