Comments:

Nifty weekly contract has the highest open interest at 24300 CE and 24000 PE while monthly contracts have the highest open interest at 25000 CE and 24000 PE. The highest OI addition was seen at 24100 CE and 24100 PE in weekly and at 25000 CE and 23000 PE in monthly contracts. FII's decreased their future index long holdings by 0.14%, increased future index shorts by 2.17% and in index options, 6.97% increase in Call longs, 4.30% increase in Call short, 0.11% decrease in Put longs and 21.11% increase in Put shorts.
