


OI & Volume Chart

In Unjha, a major spot market, the price ended at 28074.85 Rupees gained by 0.46 percent.

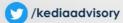

Traders are reporting decline in yield highlighting the challenges faced in coriander cultivation

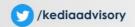
In Gondal, a major spot market, the price ended at 7453.55 Rupees dropped by -0.15 percent.
